## **TESTIMONY FOR SENATE BILL 778, RELATING TO PESTICIDES**

Honorable Chair Tokuda and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 350 members. On behalf of our members, we offer this testimony <u>in strong support</u> of Senate Bill 778, relating to pesticides.

In the debate over regulating local agriculture, there is one thing that everyone should agree to condemn: causing harm to other people.

Unfortunately, Hawai'i's pesticide code allows chemical abuse to go unchecked. Today, the Department of Agriculture must warn pesticide abusers before investigating potential legal violations. A farm that fails to take caution when using harmful chemicals, therefore, may suffer no consequences for its actions, since the warning will give owners ample time to hide any evidence of their crimes. Even when caught, chemical criminals face minimal penalties. State law currently grades pesticide abuse as a misdemeanor offense, meaning farm operators who apply dangerous doses of restricted use pesticides are met with a maximum one-year prison sentence.

In the islands, pesticide misuse poses major health risks. According to an investigation conducted by the *Cascadia Times*, pesticide application by four large agrichemical companies on Kaua'i–Syngenta, BASF Plant Science, DuPont Pioneer, and Dow AgroSciences–is ten times the national average. In their report, *Cascadia* found that a number of restricted use pesticides were overused, including chlorpyrifos, atrazine, and paraquat. A study published in the medical journal *The Lancet Neurology*, in March of 2014, found that the neurotoxin chlorpyrifos led to developmental disabilities in children. Similarly, atrazine and paraquat are banned in the European Union. Atrazine is known to contaminate groundwater supplies, while paraquat has been linked to the onset of Parkinson's disease. Yet, both herbicides remain widely popular in the

United States, where the Environmental Protection Agency has prematurely declared with "reasonable certainty" that neither carry a significant risk of harm.

Pesticide abuse is not limited to the outer islands. On O'ahu, IMUAlliance has provided services to cancer-stricken sprayers of restricted use pesticides, some of whom have are also victims of labor trafficking. Not only were our clients provided with little to no information about the health risks of the pesticides placed in their hands, they were not given equipment to protect themselves from harm. Yet, <u>similar cases have been handled by our strategic partners on the outer islands, including Kaua'i.</u>

To protect against pesticide drift impacting sensitive educational areas and making children ill-as happened in 2007 at Kahuku High and Intermediate, in which a dozen students fell ill when a nearby sod farmer ignored windy weather while applying pesticides, and <u>in 2008</u> in Waimea on Kaua'i, where dozens of students got sick after farmers applied pesticide on a <u>nearby seed corn plot</u>-it is incumbent upon lawmakers to pass legislation establishing buffer zones around schools from which the application of pesticides is restricted, as is called for by the Joint Fact Finding Group's report *Pesticide Use by Large Agribusinesses on Kaua'i*. When Ordinance 960 was struck down by a federal court in 2014, the Department of Agriculture and the Kaua'i County Office of the Mayor contracted an independent public policy group, The ACCORD 3.0 Network, to facilitate the Joint Fact Finding Group project, charging the group with gathering accurate information on the lands used by the seed companies and Kaua'i Coffee, their pesticide usage, and evidence of any possible adverse health and environmental impacts. Their finds are clear and must be implemented as quickly as possible.

We urge lawmakers to, soon, also pass legislation removing warning notice requirements from the state's pesticide code, allowing investigators to probe allegations of noncompliance without tipping off their targets. Policymakers should simultaneously raise penalties for restricted use pesticide violations that result in bodily harm or death. Carelessness should not excuse assault or homicide, even if industrial chemicals are the culprit. Finally, elected officials should make sure that the Department of Agriculture has the clear capability to refer potential violations to law enforcement for prosecution. Laws are only as good as their enforcement. It's time we started prosecuting those who sacrifice people's health to personal profit.

It is imperative that political leaders stand up for safety during this year's legislative session, given recent court rulings curtailing county jurisdiction over pesticide use, genetically modified organisms, and land management. If you wait, our children will breathe in the fallout for generations to come. Mahalo for the opportunity to testify <u>in support</u> of this bill.

It is important to note that due primarily to the presence of 4 large research based agrochemical companies, the annual pesticide use both in terms of quantity and variety is greater on the West Side of Kauai than in any other community in Hawaii.

The JFFSG's report urges the Hawai'i Governor, state lawmakers, and several state agencies to work in collaboration to better protect residents from exposure to harmful chemicals in the air and water, and to improve the monitoring of both pesticides and chronic illnesses associated with pesticide exposure. The report also calls for the implementation of a consistent, no-spray buffer policy around sensitive areas like schools to protect children from pesticide drift, and mandatory public disclosure of pesticide use by large agribusinesses throughout the state. We feel these regulatory actions should be the priority of this initiative as only regulation will adequately protect the families who live, work, and play next to these operations

In Opposition to SB 778 Relating to Pesticides Appropriate Funds to Implement Recommendations of the Kauai Joint Fact Finding Committee

Chair Tokuda and members of the committees:

The Hawaii Crop Improvement Association (HCIA) is a Hawaii-based non-profit organization that promotes modern agriculture to help farmers and communities succeed. Through education, collaboration, and advocacy, we work to ensure a safe and sustainable food supply, support responsible farming practices, and build a healthy economy.

HCIA **opposes SB 778**, which seeks to appropriate funds to implement the recommendations of the Kauai Joint Fact Finding (JFF) Committee.

Foremost, HCIA supports the legislature fully funding the Hawaii Department of Agriculture (HDOA). We have confidence in their ability to scientifically assess and implement the appropriate measures required to ensure that both public health and the environment are protected.

Our primary concern is that the JFF's findings do not support the report's recommendations. To follow are the key conclusions:

- There is no evidence of health or environmental impacts associated with the industry's pesticide use.
- Incidence of cancer among the island's population in areas rumored to be contaminated by the use of pesticides was similar to or lower than that of the rest of the state.
- Two incidents of purported pesticide exposure at Waimea Canyon Middle School were found not to be pesticide related.
- Kauai's seed companies were responsible for less than 25 percent of restricted use pesticide (RUP) use on the island.

In addition to the JFF, numerous other studies and investigations further outline why the recommendations listed in the JFF report are overreaching:



- A Hawaii Department of Agriculture Pesticide Branch investigation into 16 school evacuations over 8 years due to complaints about pesticides found that none of the incidents were due to activities of seed companies.<sup>1</sup>
- A report prepared by the Hawaii Tumor Registry for the Hawaii State Department of Health (HDOH) concluded that there is no evidence of higher incidence of cancer on the island of Kauai overall or for specific geographic regions of the island, as compared to the state of Hawaii.<sup>2</sup>
- A State Department of Health study of 136 different pesticides in surface water samples from 24 sites across the state found only a trace detection of pesticides, with the majority representing minute concentrations that fall far below state and federal benchmarks for human health and ecosystems.<sup>3</sup>
- In 2016, the Kauai Department of Water tested four water sources for pesticides and found no detectable levels of any of the 525 pesticides/herbicides, including chlorpyrifos. The independent lab also reviewed the Department's 2015 testing of several other on-island water sources, and found the same results.<sup>4</sup>

The Hawaii Department of Agriculture has the authority and expertise to promulgate additional pesticide regulations to protect the public if it determines that further regulations are warranted. It is our hope that both HDOA and HDOH will be properly engaged to assess the recommendations of the Joint Fact Finding Committee and prioritize any implementation, based on scientific fact and available resources.

It is for these reasons that we respectfully ask that this bill be deferred.

Aloha Chair Tokuda, Vice Chair Dela Cruz, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau opposes SB 778, to appropriate funds to implement the recommendations of the joint fact finding study group's report on pesticide use by large agribusinesses on Kauai.

At a time of scarce State resources but many valid and competing needs for funding, the proposed **6 million dollar** allocation to implement the scientifically unwarranted and roundly criticized JFF's recommendations that did not even comport with the group's own study findings, does not appear to be justifiable.

In fact, the standing committee (AEN) that last reviewed this bill, found that the Kauai study group arrived at the following conclusions regarding health and environmental impacts on the west side of Kauai:

(1) The Kauai health data examined is very limited and does not show a causal relationship between the pesticides used by the seed companies and health problems found on the west side or any other part of Kauai; and

(2) There needs to be additional data gathering going forward to continue to demonstrate the impacts of agricultural pesticide use.

As detailed below, this recommendation is already being implemented by the DOA.

JFF's recommendations are not a logical result of its findings

Despite the fact that the JFF group was mainly comprised of community members who came into the process already believing that large agriculture was causing problems on the west side of Kauai and who carefully scrutinized every available source of information regarding pesticide usage there, including studies, data, and public input, the group arrived at the following conclusions regarding health and environmental impacts on the west side of Kauai:

- The Kauai health data *does not* show a causal relationship between pesticides used by the seed companies and health problems found on the west side or any other part of Kauai.
- There is **no evidence** that shows causality between seed companies' pesticide use and any harm to Kauai's flora and fauna.
- Data gathering should continue.

# DOA has taken significant action to address the JFF recommendations

Both DOA and DOH have already initiated activities to address the JFF group's recommendations to assess existing environmental data and identify gaps in information required to make informed policy decisions. To determine what activities would offer the greatest benefit to local communities, they sought guidance from and formed partnerships with federal, state and research partners including: U.S. Geological Survey, U.S. EPA and the Migrant Clinicians Network, Agency for Toxic Substances and Disease Registry (ATSDR), Western States Pediatric Environmental Health Specialty Unit, Hawaii Poison Control Center, Hawaii Birth Defects Registry, John A. Burns School of Medicine, University of Hawaii School of Nursing, Hawaii Emergency Physicians Association, and Kauai Veteran's Memorial Hospital.

The result of this collaboration with experts was to initiate programs to increase environmental sampling, conduct interagency emergency response exercises for pesticide incidents, and increase public health education and outreach.

- Recent environmental monitoring of air, surface water, drinking water, and sediment has shown that there is no threat to people or wildlife from agricultural pesticides. However, to obtain more data, DOH has contracted with the U.S. Geological Survey and it is currently conducting a \$500,000 comprehensive pesticide surface water quality monitoring project over two years, with DOH providing technical and scientific assistance.
- 2. To train first responders to be adequately prepared in the case of a pesticide emergency, interagency pesticide tabletop exercises will be conducted in each county through the Hawaii State Emergency Response Commission with other organizations including Fire Departments, HAZMAT, Emergency Medical Services, Department of Education, Hawaii Occupational Safety and Health (HIOSH) and other county representatives.
- 3. Public health education and outreach is being conducted. A team from DOH has already met with Kauai physicians to resolve birth defects registry discrepancies, noted in the JFF. Since the majority of pesticide exposures reported to Poison Centers nationwide and the Hawaii Poison Center occur *in the home* and not from large-scale agricultural incidents, DOA is re-starting its "Pesticide Poisoning Prevention Services for Households" outreach program to educate families and communities about how to better protect their children and how to reach out for help in the event of potential exposure. Physicians and other healthcare professionals are being helped to recognize and manage pesticide incidents and

a children's environmental health symposium on Oahu is planned for March 2017. DOH is also working with the Hawaii Poison Center to offer Hawaii-specific information on how to report and respond to pesticide exposure through a free hotline service, operated by medical professionals 24/7. DOH conducted an Emergency Medical Services/physician training on hazardous chemicals in partnership with Kapiolani Community College and the Louisiana Poison Center with participants attending from all islands. Additional pesticide-specific trainings for each of the counties are currently being developed.

4. The "Good Neighbor Program" that more stringently restricts farmers' use of pesticides than programs in any other state has been extended from Kauai statewide.

## Upgrading DOA pesticide programs

HFB supports a robust pesticide regulatory program under the Department of Agriculture, as delegated by the U.S. EPA. To that end, we respectfully suggest that DOA receive adequate funding and positions to accomplish its duties. We also support the reasonable increase of pesticide licensing fees and the removal or raising of the Pesticide Use Revolving Fund cap on what DOA can retain to support its programs. As the safe use of pesticides is a priority within the department, funding should be allocated to programs found to require more attention: pesticide education for the general public and for immigrant farmers, and improvements made to liaison with and augment the complementary University of Hawaii CTAHR's Pesticide Safety Education Program.

HFB is concerned that, along with other pressures that make farming in Hawaii extremely challenging, further unwarranted restrictions on farming will be the demise of commercial agriculture in Hawaii, and with that, the end of any hope for self-sufficiency, while providing no additional safety for our communities.

We hope you will take our concerns into consideration as you deliberate on this bill. Thank you very much for your support of Hawaii's farmers and ranchers.

Dear Chair Tokuda, Vice Dela Cruz and members of the committee,

My name is Dr. Ashley Lukens and I am the Director for the Hawaii Center for Food Safety (CFS). CFS is a nationwide public interest, sustainable agriculture nonprofit organization whose mission centers on furthering the public's right to know how their food is produced, through labeling and other means. We have over 820,000 farmer and consumer members across the country, including nearing 11,000 in Hawai'i. On behalf of CFS and our members, I thank you for the opportunity to speak to you today regarding this important bill.

CFS has been dedicated to addressing the human health and environmental impacts of our increased reliance on pesticide use in food production, both in the State of Hawai'i and nationally. We were instrumental in providing legal and communications support in the passage of numerous ordinances relating to pesticide use and disclosure, such as Kaua'i's Bill 2491. Since 2014, as the inaugural director here in Hawai'i, I have worked closely with community members across the state, in all counties, and have played an instrumental role in the passage of Maui's moratorium on GE production until companies submit environmental and public health impact assessments.

I am also a former adjunct professor of Political Science at UH Mānoa and UH West O'ahu, where I have taught classes on food, agriculture, and policy from 2006-2016.

Specifically, according to a 2012 report by the American Academy of Pediatrics (AAP) entitled "Pesticide Exposure in Children," children exposed to chronic, low-level exposure to restricted used pesticides are at a risk of neurodevelopmental disabilities like autism and ADHD<sup>15,16,17,18</sup>, leukemia<sup>19,20,21</sup>, and asthma<sup>22,23,24</sup>.

Nine of the ten studies examining pesticides and brain cancer that have been conducted since 1998 demonstrated an **increased risk estimate of brain tumors with maternal and/or paternal exposure to pesticides**, though not all achieved statistical significance. One study, which involved 321 cases, demonstrated that **maternal exposure to insecticides before or during pregnancy was associated with a 90% greater risk of astrocytoma** (a type of brain cancer) in the child, as well as a trend to higher risk in exposed fathers<sup>25</sup>.

The direct, indirect, and cumulative impacts on public health regarding the long-term intensive commercial agriculture and associated use of pesticides have not been properly or independently evaluated. Existing federal oversight of pesticide exposure do not take into account chronic exposure to local pesticide use. Information pertaining to the intensive use of pesticides in large-scale commercial agriculture within the State is not readily available to the public. Thus, the public is unable to evaluate the full extent of negative impacts accruing to the residents and environment of Hawai'i.

The people of Hawai'i have the right to decide that the risks associated with the use of toxic pesticides in commercial agriculture are unacceptable, and take action to reduce and prevent the potential negative impacts of such use. The state has spent \$200,000 studying this issue in order for it to take informed action. THE TIME FOR THAT ACTION IS NOW.

We and our farmers are committed to using these valuable crop protection products in a manner that is safe for agricultural community as well as our neighbors. We are opposed to SB 778.

In a December press statement, the State Department of Agriculture (DOA) reported on three statewide initiatives including environmental sampling, interagency emergency response exercises for pesticide incidents, and public health education and outreach. The DOA is working closely with the Department of Health and other state, county and federal agencies to get these initiatives underway. A \$3,000,000 appropriation from the DOA's budget to address only the needs of Kauai is excessive given the competing priorities of the DOA which includes statewide water sampling and voluntary expansion of the Good Neighbor Program. Chair Tokuda, Vice Chair Dela Cruz and Members of the Senate Committee:

My name is Sarah Styan and I am a resident of Hanapepe on the west side of Kauai.

### I do not support SB 778.

The recommendations of the Kauai Joint Fact Finding group are not warranted or consistent with the findings of the report. I am very familiar with the report and recommendations because I was a member of the JFF group.

Having participated in the year plus-long review of all data, reports, interviews, field visits, and other information, I would like to make it very clear that the report recommendations were actually written in August of 2015, **well before the group even completed its investigation and report**.

When the JFF group completed the draft report, I raised the issue that the previously drafted recommendations did not match our findings; however, the facilitator Peter Adler *insisted* that we had agreed to the recommendations months ago **and they would not be revisited or changed** to accommodate what the group had learned. This was extremely disturbing.

The JFF group also received a lot of feedback from the community and experts when the draft report was released for public comment. Many reviewers noted that the recommendations were not consistent with the findings of the report. Among these were the Hawaii Department of Health, as well as the Hawaii Department of Agriculture. Despite this feedback, much of which was from experts in the fields of health, agriculture, epidemiology, and scientific research, Mr. Adler and some of the JFF participants did not want to change the recommendations to ensure that they were consistent with the findings. This was alarming since participants were previously promised that relevant comments from experts and the public would be taken into consideration and the report would be modified accordingly.

As a scientist, with a doctorate in a directly relevant field, I was astonished and sorely disappointed that the JFF group chose to ignore the excellent feedback from the many professionals who took the time to carefully review our citizen-group's work. It was one of the reasons that after more than a year of painstaking work combing through data and evidence, I

decided to resign from the JFF group rather than put my name and reputation on this document.

As you consider this bill, I hope that you will take the JFF report and recommendations for what they are -- a vehicle for the pre-ordained and unsupported recommendations of its biased membership -- rather than what they should have been -- a good-faith effort to determine facts and develop recommendations to assist our community in making sound and well-informed policy decisions.

I am writing in strong support of SB778 which appropriates funding to implement the findings of the Kauai Joint Fact Finding study group, which as indicated in Chapter 3 of the report focused on 23 RESTRICTED USE PESTICIDES; chemicals officially recognized as public health risk. When these chemicals are tested and identified as only appropriate for RESTRICTED USE, they are tested individually, and not in combinations. This is concerning to me because whenever I go to the doctor and they prescribe chemicals as medication, they always ask what other medications I am taking, because as we know chemicals in combination can behave VERY DIFFERENTLY than individual chemicals. So the effects of these combinations, especially over time, and during developmental stages such as during childhood development is completely unknown.

My understanding is that one of the things they do in some of these open air test sites, is that they specifically test for "pesticide resistance." In other words, they are basically saying, "let's see just how much of these unstudied RESTRICTED USE pesticide combinations, this massive field of plants can take." And the only way they can find out what that ceiling is, would be to keep spraying and spraying and spraying until the plants show signs of damage or die. And when I look at industry spray logs, that is exactly the kind of behavior we see.

So in summary, it appears that this industry is very frequently applying, chemicals which individually are recognized as public health risks, in combinations which have never been studied, in amounts that damages and/or kill life forms which have been specifically modified to resist these exposures. And then the whole cycle may be repeated several times throughout the year... While those same unstudied chemical combinations are carried by tradewinds and runoff and continue to accumulate in our schools, where there are children who have NOT been modified to resist these RESTRICTED USE pesticides in unstudied combinations.

I was one of the two physicians who served on the Joint Fact Finding task force. I am a board certified pediatrician and a former CEO of Wilcox Hospital on Kauai. Over a eighteen month period, the task force reviewed the world's literature on the issues of pesticides and health. In addition we reviewed the medical data and the Department of Education's data concerning the Westside communities which are potentially affected by large scale pesticide spraying

We found the following:

- 1. The American Academy of Pediatrics begins their 2012 policy statement on pesticides by stating clearly that there is" increasing concern" about "**low level exposure** on child health".
- 2. This increasing concern about low level and chronic exposures has been amplified by EPA reports and by numerous other medical societies and studies.
- 3. We found the Westside community to be one the least healthy communities in the state by many health measures.
- 4. Our concern was heightened by increases in developmental disorders in children in these Westside Communities as compared to the other communities on Kauai.
- 5. We also very clearly pointed out that due to the small population and the virtual lack of any environmental or biologic monitoring, we could not say with any certainty what was causing these adverse health findings.

- 6. Our conclusion was that if any community in Hawaii wanted to really know if they are being affected by pesticide exposure there needs to be adequate testing of the environment and of the population for pesticide exposure.
- 7. This monitoring should be funded and there should be oversight and coordination of these studies and other efforts by a balanced, science- oriented pesticide committee.
- 8. For this testing to be scientific it requires knowledge of what has been sprayed and where. Another of our recommendations is that the good neighbor policy be statewide, mandatory and audited.

I would also urge this committee to view pesticide exposure in the context of past environmental issues that were also initially minimized but subsequently found to be all too hazardous to health. I say this with particular regard to chlorpyrifos. It is a known neurotoxin and it is the second most heavily sprayed Restricted Use Pesticide on Kauai. Due to its toxicity the EPA has recommended its complete prohibition for agricultural use but until that motion becomes law its use will continue in proximity to our communities.
