SENATE BILL NO. 779 RELATING TO PESTICIDES

Chairperson Gabbard and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 779. This bill expands the membership of the advisory committee on pesticides, requiring the addition of representatives from the Hawaii Department of Education, each county mayor's offices, and Hawaii Farmers Union United, as well as a medical expert and a non-governmental organization scientist. This bill also requires expansion of duties to include:

- 1. Establishing of state standards for chronicity to account for low-level continuous exposures;
- 2. Evaluation and recommendation to legislature regarding specific changes to the State's pesticide law;
- 3. Revision and expansion of the Kauai Agricultural Good Neighbor Program; and
- 4. Establishment of a comprehensive buffer zone policy

The Department of Agriculture opposes this bill.

The role of the advisory committee on pesticides is to "advise and assist the department in developing or revising laws and rules to carry out and effectuate the purposes of this chapter and in advising the department in pesticide problems". This

bills seeks to expand the committee to include members who have no expertise in pesticide use and imposes duties that are not under the purview of the department. This would dilute the goal of the committee and result in the inability of the Department to fulfill its mission to effectively regulate the use and distribution of pesticides through applicator certification, education and outreach, product registration and licensing, use and misuse surveillance, and administration of enforcement actions.

Title of Bill: SB 0779 RELATING TO PESTICIDES.

**Purpose of Bill:** Expands the membership of the pesticide advisory committee to include a representative from the Department of Education (DOE), each county mayors' office, a medical expert, and a non-governmental organization scientist. Expands the duties of the pesticide advisory committee to include establishment of state standards for chronicity, recommendation to the legislature of specific changes to the State's pesticide laws and regulations, expansion of the good neighbor program, and establishment of a comprehensive buffer zone policy for the State.

#### **Department's Position:**

The DOE supports expanding the membership of the pesticide advisory committee to include a representative from the DOE. The DOE implements an Integrated Pest Management (IPM) program that takes a comprehensive approach to reduce the impact of pests and pesticides at school facilities.

IPM incorporates prevention, monitoring and control activities to drastically reduce the use of pesticides, thereby minimizing the toxicity and exposure to students at school facilities. However, where the use of pesticides are required, the DOE would like to provide input at the advisory level for pesticides that are least toxic to students while effectively controlling pests.

Aloha Chair Gabbard, Vice Chair Riviere, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau opposes SB 779.

We oppose this bill because it is unnecessary, inappropriate, and will delay necessary rule-making that ensures the safety of the community and farmers.

HFB has carefully monitored pesticide issues across the nation and within the State for decades. We and our farmer-members have supported and participated in many programs within the Department of Agriculture and the University of Hawaii to improve pesticide education and ensure the safe use of pesticides.

Unfortunately, there is currently a dangerous disconnect between public perception and scientific reality that is exacerbated by the frightening propaganda used by mainland activist groups now operating in Hawaii. Their false claims purposefully ignore the strict and effective regulatory process, based on more than 120 health, safety and environmental tests to ensure the safety and effectiveness of each pesticide before it is registered for use by the EPA under two federal laws: the Federal Insecticide, Fungicide, and Rodenticide Act and the Federal Food, Drug, and Cosmetic Act.

Under these laws, EPA ensures that each pesticide "will perform its intended function without unreasonable adverse effects on the environment." To meet this standard, *every* crop protection product is evaluated over a period of many years, for potential

effects to humans, wildlife, plants and other organisms. Pesticide products are not allowed on the market if EPA deems that there are *any* questionable results from the studies, including years-long chronic exposure toxicity testing dictated by some of the foremost toxicological scientists in the nation. These studies involve testing chronic effects of lifetime exposure, effects on reproduction, mutagenic effects on genes and inherited traits and carcinogenic effects during lifetime exposure. It's a complicated, lengthy, and expensive process.

The reality is that even plants make their own pesticides to protect themselves from harm and we eat those on a daily basis without a thought.

In many cases, pesticides are necessary. And they are being used safely. In fact, many members of the public use pesticides on a daily basis but do not realize it. By definition in our laws, pesticides include not just agricultural products but also:

- Disinfectants like Lysol sprays, wipes, and toilet bowl cleaners
- Clorox bleach
- Sterilizers, cleaners, and disinfectants used in hospitals
- Restricted use pesticides put into our drinking water so we don't get sick from pathogens
- Ant, roach, and rat traps.
- Neem oil products and other "Organic" products
- Termiticides used to protect our homes
- Products to keep our pets healthy and parasite-free

Many farmers in Hawaii also use pesticides (including organic ones) to protect their crops against the persistent onslaught of devastating introduced insects and weeds. Without the careful and judicious use of these products, many farmers could not stay in business.

The bill will hurt regulatory efforts to respond in a timely way to new science and real concerns. Expanding the membership of the pesticide advisory committee to include a representative from the Farmers' Union, DOE, each county mayors' office, a medical expert, and a non-governmental organization scientist will make the committee unwieldy, without adding to its collective expertise.

Expanding the duties of the pesticide advisory committee to include establishment of state standards for chronicity, recommendations to the legislature of specific changes to the State's pesticide laws and regulations, expansion of the good neighbor program, and establishment of a comprehensive buffer zone policy for the State *is inappropriate* since the State DOA, and the U.S. EPA, has the staff, the expertise, and the authority to propose each of those things, if needed. Adding more non-expert community members to the Committee will not accomplish the presumed goal, which is to ensure the safe use of pesticides in Hawaii. In addition, the Committee already has the broad authority to "advise and assist the department in developing or revising laws and rules to carry out and effectuate the purposes of this chapter and in advising the department in pesticide problems."

The new Committee mandates added by this proposed law are in areas of extreme complexity and require the expertise of trained specialists in that specific field. The Committee already includes members with that expertise along with community representation.

Thank you for your careful consideration of our comments in opposition to this bill, and for your support of Hawaii's farmers and ranchers.

## Hawai'i Center for Food Safety strongly supports: SB779

Dear Chair Gabbard, Vice Chair Riviere and members of the committee,

My name is Dr. Ashley Lukens and I am the Director for the Hawaii Center for Food Safety (CFS). CFS is a nationwide public interest, sustainable agriculture nonprofit organization whose mission centers on furthering the public's right to know how their food is produced, through labeling and other means. We have over 800,000 farmer and consumer members across the country, including nearing 10,000 in Hawai'i. On behalf of CFS and our members, I thank you for the opportunity to speak to you today regarding this important bill.

CFS has been dedicated to addressing the human health and environmental impacts of our increased reliance on pesticide use in food production, both in the State of Hawai'i and nationally. We were instrumental in providing legal and communications support in the passage of numerous ordinances relating to pesticide use and disclosure, such as Kaua'i's Bill 2491. Since 2014, as the inaugural director here in Hawai'i, I have worked closely with community members across the state, in all counties, and have played an instrumental role in the passage of Maui's moratorium on GE production until companies submit environmental and public health impact assessments.

I am also a former adjunct professor of Political Science at UH Manoa and UH West O'ahu, where I have taught classes on food, agriculture, and policy from 2006-2014.

I am writing in strong support of SB779 which amends the existing make-up of the pesticide advisory committee to better reflect the current economy and current pesticide concerns for the state. SB779 directs that the committee shall:

(1) Establish state standards for chronicity to account for low-level continuous exposures;

(2) Evaluate and recommend to the legislature specific changes to the State's pesticide laws and regulations;

- (3) Revise and expand the Kauai agricultural good neighbor program statewide; and
- (4) Establish a comprehensive buffer zone policy for the State.

As the Kauai Joint Fact Finding Study group determined, the regulatory framework for pesticides in the state of Hawaii fails to protect the people of our state. The JFFSG's pivotal report urges the Hawai'i Governor, state lawmakers, and several state agencies to work in

collaboration to better protect residents from exposure to harmful chemicals in the air and water, and to improve the monitoring of both pesticides and chronic illnesses associated with pesticide exposure and this advisory committee will help facilitate bridge the divide between people and the agencies that are meant to protect them.

While we applaud the amendment to the existing pesticide advisory committee make-up to include one medical professional, we strongly believe that additional representation from the medical community is critical to effectively address impacts of pesticide use. The medical literature on pesticides is a growing field and there are important debates about chronic exposure that will not be adequately addressed if there are not multiple seats for the relevant medical fields. To that end, I would encourage the committee to have seats for a peditrician, OBGYN, medical toxicologist, an oncologist, and an endocrinologist. Because these medical professionals understand the various ways pesticides impact human health, they will be able to advise agencies on how to best protect our families. Currently, the composition of the committee seems to frame the competing voices in the debate as industry versus environmentalists – however it is clear that when it comes to regulation it is the medical community that must step up to help ensure we are properly protected.

Additionally, because pesticide drift has already impacted workers in our state, we feel that their union representation should also be present on this committee: to that end we suggest seats for the HSTA, Nurses Union, and HGEA to ensure that if companies are spraying pesticides next to schools, hospitals, and government buildings, that employees appropriately protected.

The people of Hawai'i have the right to decide that the risks associated with the use of toxic pesticides in commercial agriculture are unacceptable, and take action to reduce and prevent the potential negative impacts of such use.

Thank you for this opportunity to provide testimony, and I am happy to provide further analysis or respond to any follow-up questions from the Committee.

#### Hawai'i Alliance for Progressive Action strongly supports: SB779

Dear Chair Gabbard, Vice Chair Riviere and members of the committee,

My name is Anne Frederick and I am the Executive Director for the Hawai'i Alliance for Progressive Action (HAPA). HAPA is a statewide environmental, social and economic justice organization. HAPA emerged out of the community-led movement on Kaua'i to enact greater regulations around pesticide use and disclosure, which led to the passage of Bill 2491. HAPA's fair and sustainable food systems work focuses on protecting Hawai'i's environment and the health of its residents from the potentially harmful pesticide impacts. HAPA engages over 10,000 local residents annually through our work.

I am writing in strong support of SB779 with amendments.

SB779 directs that the committee shall:

(1) Establish state standards for chronicity to account for low-level continuous exposures:

(2) Evaluate and recommend to the legislature specific changes to the State's pesticide laws and regulations;

(3) Revise and expand the Kaua'i agricultural good neighbor program statewide; and

(4) Establish a comprehensive buffer zone policy for the State.

As the Kaua'i Joint Fact Finding study group (JFFSG) report concluded, the regulatory framework for pesticides in the state of Hawai'i fails to protect the people of our state, and current requirements for data collection are inadequate. The JFFSG report clearly recommends the Hawai'i Governor, state lawmakers, and several state agencies to work in collaboration to better protect residents from exposure to harmful chemicals in the air and water, and to improve the monitoring of both pesticides and chronic illnesses associated with pesticide exposure. This advisory committee will help bring the necessary expertise and community voice to meaningfully address these long standing concerns.

While we applaud the proposed expansion of the existing pesticide advisory committee we strongly recommend that the composition should also include additional health professionals, members of impacted communities, and labor/worker representation.

The recent hospitalization of Syngenta fieldworkers which has led to an ongoing EPA investigation has shed light on a worker safety concerns and the inability to track the long-term impacts on these "contract workers" who are imported to Hawai'i for short periods of time.

We also recommend the inclusion of deadlines and reporting requirements for implementing the measures outlined in the bill.

A further recommendation is to expand reporting requirements in the good neighbor program to include General Use Pesticide disclosure by the largest users of Restricted Use Pesticides.

SB779 is an important next step in enacting the recommendations set out by the State sponsored JFFSG report. We strongly urge the committee pass this critical measure and other related measures today.

On behalf of the Western Plant Health Association (WPHA), I am writing to express our **opposition** to SB 779, which would revise the membership and duties of the pesticide advisory committee. WPHA represents the interests of fertilizer and pesticide manufacturers, agricultural biotechnology providers, and agricultural retailers in Hawaii, California, and Arizona.

WPHA appreciates the author's intent to allow greater diversity of participation in the advisory committee. However, WPHA is also concerned about the expansion of the role of the advisory committee. The scientific assessment and establishment of rules for the safe use of pesticides is the responsibility of the Hawaii Department of Agriculture (HDOA). WPHA believes that the proposed make-up of the committee is not qualified to undertake the establishment of rules focused on the sound scientific assessment of products, to establish scientifically valid programs, or qualified to objectively assess the effectiveness of current or future programs. We believe that the role of an advisory committee is to advise the HDOA, not direct the department. WPHA strongly believes that the technical duties proposed for the advisory committee should remain the sole responsibility of the HDOA.

WPHA supports HDOA's plans to undertake thoughtful projects that can develop scientifically sound data on risks from pesticide use. We also believe that this responsibility should continue to remain fully with HDOA and with the government agencies that collaborate with HDOA. For these reasons WPHA opposes SB 779. We thank you for your consideration of our comments.

The Kaua'i Joint Fact Finding Study group determined that the State's regulation of pesticides has failed to protect our residents. The report urges the State to protect us from exposure to pesticides and to do a better job of monitoring their use. There is a massive oversight in the proposed expansion of this advisory body. Currently there is only one seat for the medical community but I think this committee must include a broad cross section of medial professionals who can help the government better understand how human health is impacted by both acute and chronic exposure to pesticides. The medical literature on chronic exposure to pesticides is a growing field and there are important concerns that will not be adequately addressed if there are not multiple seats for the relevant medical fields. Because these medical professionals such as toxicologists, endocrinologists and pediatricians understand the various ways pesticides impact human health, only a broader cross section will be able to advise agencies on how to best protect our families. The people of Hawai'i have the right to live free from the fear that industry will harm their health and safety. I urge you to support SB779. Mahalo for considering my testimony.

Comments: Aloha Senator Gabbard and Committee Members, I am testifying in strong support of SB779 with amendments. SB779 which expands the advisory committee on pesticides and further supports recommendations contained in the State sponsored Joint Fact Finding (JFF) report. While I commend this attempt to expand the composition of the committee. I strongly encourage the measure be amended to include representatives from labor organizations, citizens living in highly impacted communities as well as additional healthcare professionals. The ongoing EPA investigation into the pesticide exposure of fieldworkers on Kauai by Syngenta has highlighted the fact that many of the individuals exposed to pesticides on a regular basis are "contract laborers" who are imported into Hawaii for short periods of time, not protected by organized labor and without community or family support networks. In addition, the measure must included firm deadlines and reporting requirements for achieving the list of added responsibilities detailed in the Bill. Without firm deadlines and public reporting requirements this well intended measure could very well never yield meaningful results, and instead simply become a scapegoat blamed for the lack of progress. It seems that all of the below tasks represent ongoing responsibilities while some are essentially initiating new regulation. Each will require a different time-line, different amounts of required staff support and different levels of professional expertise. Without clear time lines and strong commitment of administrative support these valuable recommendations will languish and inaction will prevail. (1) Establish state standards for chronicity to account for low-level continuous exposures; (2) Evaluate and recommend to the legislature specific changes to the State's pesticide laws and regulations; (3) Revise and expand the Kauai agricultural good neighbor program statewide; and (4) Establish a comprehensive buffer zone policy for the State. A further recommended amendment is to make it clear that "Revise and expand the Kauai agricultural good neighbor program statewide;" includes including making reporting requirements mandatory and also including General Use Pesticide disclosure (such as glyphosate) by the largest users of Restricted Use Pesticides. In summary I am suggesting amendments that: Expand the composition of the committee to include additional medical professionals, members of impacted communities, and labor/worker representation Establish clear deadlines and public reporting requirements that will ensure the Department and the

Committee accomplish the outlined responsibilities in a timely manner. Make it clear the intent is to make the Good Neighbor Program mandatory and that it will include General Use Pesticide disclosure by the largest users. SB779 is a critical component necessary in fulfilling the objectives and recommendations contained within the State sponsored Joint Fact Finding (JFF) report and I strongly encourage this committee to pass this measure and other related measures today. The passage of S.B. 778, S.B. 779, and S.B. 804 are necessary (1) to determine by the collection of environmental and human data (e.g., urine testing) if residents living near agricultural operations (e.g., west side Kauai residents) are at risk from exposures to pesticides and (2) to provide adequate buffer zones for pesticide applications as adopted by the State of California. As the former senior health and science advisor for U.S. EPA in Chicago, I led or participated in more than 150 federal investigations regarding human exposures to toxic chemicals and pesticides working directly with agencies such as the Centers for Disease Control (CDC) and health and environmental departments in the States of Illinois, Michigan, Wisconsin, and Ohio. In 2015-2016, I served as a pro bono liaison expert for the JFF committee.

Only a portion of the 2016 JFF recommendations has been fulfilled by State agencies to address public health issues. *Passage of these bills will fund critical data collection (soils, dusts, air, and human biological) to assess if unsafe pesticide exposures are occurring and to prevent future potential pesticide exposures as strongly recommended in the 2016 JFF report.* The JFF properly concluded there is inadequate pesticide data to determine if residents most proximal to agricultural operations (e.g., Waimea area) are at risk. It is not technically difficult to collect the proper data to assess risks to public health as such information has been collected and evaluated in numerous published studies (see references).

Peer reviewed literature indicates associations with adverse health effects (e.g., autism, autism spectrum disorders, ADHD, fetal defects) and proximity (up to 0.9 mile) to California agricultural fields or known pesticide exposures within ¼ mile. Some of these California studies directly measured the amount of pesticides in the human biological samples (e.g., urine, blood) finding strong statistical correlations with adverse health effects in children. There are numerous areas in Hawaii where residential properties are within ¼ mile of major agricultural operations using highly toxic pesticides. *The JFF report strongly recommended the collection of urine samples to assess human exposure, but no funding mechanism has been established by the State. Without environmental and urine data from communities nearest agricultural fields it will not be possible to assess the risks of agricultural pesticides to public health and put the proper measures (e.g. buffer zones) into place that will protect public health.* 

On Kauai and at other Hawaiian locations a number of restricted use pesticides, with known adverse human health effects documented in the literature, are frequently applied to fields. Chlorpyrifos, associated with adverse health effects in children, is heavily used, as is glyphosate, now classified by IARC as a probable human carcinogen. It has been well documented that dusts and soils are transported from fields into nearby residential properties. A comprehensive review of 35 publications (published 1995–2013) found that

agricultural drift, as measured by proximity to treated farmland, was associated with higher detection rates and concentrations of common agricultural pesticides in residential indoor dust. Photographs of some Waimea agricultural operations have shown wind blown dusts from fields and photographs document deposited soils/dusts (e.g., found on window sills) on nearby residences as well as interior dust accumulation possibly emanating from proximal fields.

The historical incidents at Waimea Canyon Middle School (WCMS) and the 2016 chlorpyrifos pesticide exposure case involving workers for Syngenta resulting in a \$5 million EPA fine, demonstrates that serious pesticide safety issues remain. For the record, there is no technical evidence to support the invalid conclusion that stinkweed caused the adverse health effects among children at Waimea Middle School. Data from an unpublished UH study clearly shows that methyl isocyanate, a toxic air component of stinkweed, was 230 times below a California Air Health Criteria and 12 times lower than at at active stinkweed site on Maui. Some have suggested that mass hysteria (psychogenic illness) as the probable cause of the WCMS events. In my 30 years investigating chemical-related health cases in conjunction with state and federal health agencies we never came across a mass psychogenic event. The repeated events at the Kauai school, the severity of the symptoms, and no such determination of hysteria by attending health providers make the psychogenic hypothesis unlikely.

Definitive conclusions could have been more readily drawn in the WCMS episodes and in the recent 2016 Syngenta case if blood and urine samples had been analyzed for pesticides. Pesticide residues may have been missed during the WCMS analytical testing because comprehensive pesticide analyses were not conducted. Field test kits to assess pesticide exposure (cholinesterase depression) should be provided at health care centers near major agricultural operations and a State funding mechanism is needed to test blood and urine in unusual, acute pesticide episodes. Human samples should be sent to CDC for testing and environmental samples to EPA certified mainland laboratories to verify results obtained by State laboratories. *At this time, it is unclear if HDOH and HDOA will fund and implement these much needed approaches as routinely done in California.* 

The concentrations of pesticides in air, soils, and exterior/interior dusts in Hawaiian residential areas nearest agricultural operations are unknown. Based upon my experience and a review of the west side Kauai situation, an environmental sampling study of residential properties and testing of urine samples, should be undertaken by State agencies in conjunction with national pesticide experts, especially those at the University of California at Berkeley. The passage of bills S.B. 778, S.B. 779, and S.B. 804 will fund those studies as recommended in the JFF report. Without passage of these bills, pesticide issues will continue to arise and it will not be known if the public is adequately protected.

I am testifying in strong support of SB779 which expands the advisory committee on pesticides and further supports recommendations contained in the State sponsored Joint Fact Finding (JFF) report.

I was one of the two physicians who served on the Joint Fact Finding task force. I am a board certified pediatrician and a past CEO of Wilcox Hospital on Kauai. Over a fourteen month period, the task force reviewed the world's literature on the issues of pesticides and health. In addition we reviewed the medical data and the Department of Education's data concerning the Westside communities which are in proximity to the pesticide spraying by the large seed companies and Kauai Coffee.

## We found the following:

- 1. The American Academy of Pediatrics begins their 2012 policy statement on pesticides by stating clearly that there is" increasing concern" about "low level exposure on child health".
- 2. This increasing concern about low level exposures has been amplified by EPA reports and numerous other medical societies and studies.
- 3. We found the Westside community to be one the least healthy communities in the state by many health measures.
- 4. Our concern was heightened by increases in developmental disorders in children in these Westside Communities as compared to the other communities on Kauai.
- 5. We also very clearly pointed out that due to the small population and the virtual lack of any environmental or biologic monitoring., we could not say with any certainty what was causing these adverse health findings.
- 6. Our conclusion was that if any community in Hawaii wanted to really know if they are being affected by pesticide exposure there needs to be adequate testing of the environment and the population for pesticide exposure.
- 7. This monitoring should be funded and there should be oversight and coordination of these studies and other efforts by a balanced, science-oriented pesticide committee.
- 8. I believe that this bill should be amended to include deadlines for the proposed committee's action items. If the there are no deadlines, the committee runs the risk of being an excuse for inactivity.
- 9. I would urge this committee to view pesticide exposure in the context of past environmental issues that were also initially minimized but subsequently found to be all too hazardous to health. I say this with particular regard to chlorpyrifos. It is a known neurotoxin and it is the second most heavily sprayed RUP on Kauai. Due to its toxicity the EPA has recommended its complete prohibition for agricultural use but until that motion becomes law its use will continue in proximity to our communities.
