My name is Keith Dane. I am the Hawaii Policy Advisor for The Humane Society of the United States (HSUS), and I appreciate the opportunity to submit this written testimony in support of Senate Bill 802 on behalf of our Hawaii members and supporters.

At least 24 states currently have some oversight mechanism for animal rescue and care entities. While approached differently in each state, the mechanisms commonly involve a form of licensing and registration, and a designated oversight agency, which can perform inspections and investigations. While the majority of animal shelters, rescues, sanctuaries and other care facilities operate above minimal animal care standards, there are unfortunate instances where these facilities are not adhering to accepted animal care practices and may even be committing acts of neglect and cruelty.

This bill allows for appropriate regulation and oversight of such facilities, as well as a penalty framework to address non-compliance. We are in agreement with the concept of and need for this legislation, however want to note two issues that could possibly pose problems as the bill is currently worded.

The first is the definition of "enforcing agency" which is the agency designated by the county to perform the duties of this bill. Hawaii counties currently contract with animal shelters to perform animal control duties and animal care. If these entities are designated as the enforcing agency by the county, they would be put in the position of inspecting and licensing themselves, which is not best practice. Additionally, this creates an awkward situation for those shelters as the law would not allow them to demonstrate to the public with the same level of confidence as other entities that they comply with the regulations. Ideally, the enforcing agency would be required to be an entity other than the one regulated, or at a minimum, an alternative agency should be designated for the enforcement of this section upon any animal rescue entities where self-regulation would create potential conflicts of interest.

Second, the definition of "animal rescue entity" is purposefully broad, in order to apply to the wide variety of animal care facilities that exist within the state. This is appropriate, however we want to ensure that this definition is not interpreted to apply to caregivers of unowned cats who engage in trap/neuter/return programs, and who may occasionally receive donations from friends or neighbors. The regulation of such caregivers is not the intent of this bill, and we request that consideration be given to possible amended language to prevent this potential confusion.

We urge committee members to support SB 802, to ensure that animals throughout the state are appropriately protected while under the care of sheltering and rescue entities.

Dear Chairs Gabbard & Nishihara and Committee members,

The West Hawaii Humane Society strongly supports SB802. More than 20 states have similar laws that license animal care facilities. While most animal shelters and rescue facilities operate above basic animal care standards, there have been numerous cases across Hawaii where well-intended individuals took in more animals then they could adequately provide for, resulting in unnecessary and preventable suffering.

Further, since Hawaii has no laws or regulations governing animal care facilities, any person(s) could potentially "start" a rescue without any oversight. While our animal cruelty laws do apply to any person, including an organization, some facilities have denied access to animal control agencies to determine if the animals are being provided appropriate veterinary care and engaging in necessary disease prevention practices. This measure aims to assist animal care facilities *prior* to the development of animal care, public health or public safety concerns. This measure gives the authority to the counties to designate such agency, since there is no state agency that currently oversees domestic animal welfare issues.

Finally, we feel that any legitimate animal care agency would be glad to cooperate with authorities on ensuring the animals under their care are being appropriately provided for, especially if such persons/organizations are actively soliciting donations from the public, as a bona fide not-for-profit organization, and that is already required to be registered with the Hawaii Attorney General's Office.

Dear Senators:

I am writing on behalf of the National Animal Interest Alliance (NAIA), a broad-based animal welfare organization founded in 1991 to provide fact-based answers to complex and controversial issues regarding animals. We are dedicated to securing high standards of animal care and treatment; and to preserving the human-animal bond. Amongst our members in Hawaii are pet owners, hobby breeders, rescuers and animal professionals, scientists and veterinarians.

NAIA supports the idea and intent of SB 802, but would like to suggest some changes and amendments to simplify the bill. We applaud the idea of bringing shelters and rescues under the purview of some oversight, and particularly requiring the reporting of valuable data. However, rather than delegating the oversight to county level and requiring entities that may not be capable to create further ordinances and license requirements that may vary widely from county to county, we would like to suggest starting with a simple mandatory, state level registration. Animal rescue entities would be required to register with a state entity, such as the Department of Agriculture as other states have done, and to report data so that a better understanding of the number of animals being overseen by rescue may be collected. This data can be used to determine what type of further regulation may be needed in the future for animal rescue entities through one process across the board.

Please consider our suggested amendments to SB 802, which will simplify the bill and better achieve regulation of shelters and rescue in the long run.

## A BILL FOR AN ACT

RELATING TO ANIMALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The Hawaii Revised Statutes is amended by adding a new chapter to be appropriately designated and to read as follows:

#### "CHAPTER

#### REGULATION OF ANIMAL RESCUE ENTITIES

§ -1 Definitions. As used in this chapter:

"Animal" means any nonhuman mammal, bird, reptile, amphibian, or fish.

"Animal rescue entity" means an individual or organization, including but not limited to an animal control agency, humane society, animal shelter, animal sanctuary, or boarding kennel, but excluding a veterinary facility, that keeps, houses, and maintains in its custody on site or elsewhere ten or more animals and that solicits or accepts donations in any form.

"Enforcing agency" means the agency designated as the enforcing agency by the county. (This needs to be changed to a state level agency for unified process statewaide) § -2 License Mandatory registration required. (a) An animal rescue entity shall obtain a license issued by register with the enforcing agency in accordance with this section and comply with the following licensing requirements:

(1) Any rules or ordinances adopted by the enforcing agency;

(2) Payment of a reasonable fee, as determined by the enforcing agency, for a license registration or an annual renewal of the license registration to provide for the actual cost of enforcing this section; and

(3) Payment of the license fee to the director of finance of the county in which the entity operates.

(3) Complete application that includes the physical address and agent for the animal rescue entity.

(b) Each county council shall have the power to set standards for animal rescue entity licenses. An applicant for an animal rescue entity license shall demonstrate that the applicant complies with all standards imposed under applicable law.

(c) The enforcing agency shall not issue or renew a license under this section unless the animal rescue agency is in compliance with the requirements of this chapter.

(d) An animal rescue entity may transfer a license issued under this section to another individual or organization with the written consent of the enforcing agency; provided that the transferee otherwise qualifies to be licensed as an animal rescue entity under this section and rules applicable to the transferee and does not have a certified unpaid debt to the State. The transferee shall submit a signed release to the enforcing agency permitting the performance of a background investigation of the transferee, and the enforcing agency shall conduct the background investigation.

§ -3 Recordkeeping; requirements. (a) An animal rescue entity shall keep a record for each animal in its custody that contains the following information:

(1) The conditions under which the entity came into custody of the animal, including date of intake and source of the animal;

(2) The date of birth of the animal or, if the date of birth is unknown, the approximate age of the animal;

(3) The species, sex, breed type, and weight of the animal at intake;

(4) A photograph of the animal taken within twenty-four hours of intake;

(5) The number of offspring the animal produced while in the possession or control of the entity, if applicable; and

(6) The disposition the entity makes of each animal possessed by, controlled by, or in the charge of the entity, including date and manner of disposition, including euthanasia, and the name and address for any individual or organization taking possession, control, or charge of an animal from the entity.

(b) Records kept in accordance with subsection (a) shall be kept by the animal rescue entity for three years from the date of disposition of each animal in its custody.

(c) An animal rescue entity shall permit an authorized representative of the enforcing agency to inspect records of the entity required by this section and shall furnish reports and information as requested by the enforcing agency.

(d) Records kept by an animal rescue entity in accordance with subsection (a) shall be reported to (the designated state enforcing agency) by February 15 of each year for the previous calendar year. The data shall be compiled by (the designated state agency) and made available to the public.

S -4 Inspection. (a) Whenever an authorized representative of an enforcing agency is advised or has reason to believe that an animal rescue entity is operating without a license, the representative may visit and conduct an on-site investigation of the premises of the animal rescue entity. (b) At any reasonable time, an authorized representative of an enforcing agency may conduct an on-site investigation of the premises of any licensed animal rescue entity to determine whether the entity is in compliance with the requirements of this chapter.

§ -5 Penalty. (a) A violation of this chapter by an animal rescue entity may result in imposition of civil penalties to be determined by the enforcing agency, including but not limited to the impoundment of all animals under the entity's control, the revocation of the entity's license to operate as an animal rescue entity, and civil penalty of not more than \$500 per violation.

(b) Before a civil penalty may be imposed under this section, the enforcing agency shall adopt rules or ordinances to:

(1) Ensure that an individual or organization who is the subject of an alleged violation receives notice of the allegations and potential imposition of civil penalties;

(2) Allow the opportunity for a hearing prior to the imposition of civil penalties; and
 (3) Allow the opportunity for judicial review of the imposition of civil penalties.

Any animal rescue entity that fails to report the information required under sections 3 of this act within 30 days of the date required may not adopt animals to the public or transfer animals to another releasing agency until the report is filed with the Department.

§ -6 Disposition of fees and penalties. All moneys received by the director of finance under this chapter shall be paid into the a general fund of the respective county and shall be used for enforcing agency operations taken pursuant to this chapter and applicable ordinances."

SECTION 2. This Act shall take effect on July 1, 2017.

Comments: SB 802 - I oppose because it will cause a negative ripple against all T-N-R-M programs because people will be afraid to be open about the number of animals needing to be spay or neutered, as they will be afraid that they will be turned in, and the animals they are protecting will be taken from them. It will also cause more animal abandonment, more unwanted litter births. Our organization Hui Pono Holoholona supports low cost/no cost spay and neuter for dogs and cats. We go into neighborhoods, in subdivisions, rural areas, and farms to get their animals on S/N schedule whether it's a caregiver for a cat colony or pet owners. SB 802 will close doors to us because people who do good care for their animals, will be afraid to be mislabeled as hoarders. At our clinic's we provide microchipping and those specific Identification number per animal is given to the client, a copy to our local Humane Society, and we keep a record. If SB 802 is passed, our local Humane Society could misuse that information if the owner has more than 10 animals. As an example: What happens if the owner has three dogs, and three cats. This same person finds a pregnant dog, decides to keep it but before it can get a veterinarian appointment for a spay it has four puppies. Now with 11 animals, puppies are not old enough to be adopted out but will be termed as a hoarder. Testimony by Alicia Maluafiti, PDP Board President In opposition to SB 802 - Relating to Animals

Aloha Chairs Gabbard and Nishihara and Members of the Committee,

Poi Dogs & Popoki (PDP) is a nonprofit animal welfare organization with a mission to help people and their pets. We oppose SB 802.

This bill may have been introduced as a result of the recent investigation into Friends for Life, the animal rescue in Makaha. Many of us in animal rescue do not condone the conditions in which the dogs were kept, but we also do not believe SB 802 is the solution. While there are many issues that contributed to the situation in Makaha, the acts were done out of love of animals and to save lives. There is no "profit" in animal rescue. The more egregious animal cruelty cases involve breeders – not animal rescues. So if the legislature is interested in curbing animal cruelty, regulating breeders would be a more important first step.

Passing SB 802 would effectively stop people from rescuing animals. Those of us that rescue animals already spend our own time and own dime doing this volunteer work. PDP was specifically organized to help people helping animals. So we work directly with other small nonprofits as well as individuals who cannot afford the costs of spay and neuter, veterinary care, and other financial challenges – many of which are the reasons why people hesitate to do rescue in the first place. Placing these rescued animals into foster homes and finding avenues to adopt them into permanent homes are additional challenges. To do this kind of work requires a 100% commitment and the end game for us simply another life saved from euthanasia. We are on the front line doing this for love and do not deserve a regulatory burden in addition to the challenges we already face.

We euthanize 7 out of 10 animals on Oahu alone. While feral cats are the statistical lead, Hawaiian Humane Society (animal control) reports that they euthanize animals that are:

- Fearful, aggressive towards humans or other animals, unsocialized, inappropriate elimination
- Ringworm, scabies, lice, and other skin diseases like mange, upper respiratory infection, injury, chronic health issues, dental issues, and other diseases
- Unweaned or under 6 weeks of age (kittens) or 4 weeks of age (puppies)

Of the approx. 9,500 cats taken in by HHS, 7,600 were euthanized. Of the 4,400 dogs taken in, 900 were euthanized. And according to the animal control contract report to the City & County of Honolulu, HHS reports that ZERO "adoptable" animals were euthanized. These statistics are ONLY for animal control. They do not include the surrenders by owners. To put that into perspective, in the 2015 FY, HHS took in 16,100 animals as part of their contract with the City. But their Annual Report for that period indicates over 22,000 animals arriving and the same "methodology" for identifying animals to be euthanized still applies.

Without the many small groups (organized as nonprofits or not) and many more people doing animal rescue, our euthanasia rate would be even higher.

Comments: On \*SB 802, the enforcement of it could really damage our animal foster care network. In the (d) section, if a qualified 501c3 asks a foster care mom to foster more than 10 animals until they are adopted out, they would need a transferred license and the transfer approved by the enforcing agency. This creates fees, time delays and bureaucracy. By having to get written consent by the "enforcing agency". and if that is the County Animal Control agency in HPD or the Animal Control enforcement agency, Humane Society, it could bog down our system and/or put our foster moms at risk and the animals being rescued at risk. Dear Committee Members,

I am writing in opposition to SB 802 in its current form.

While I do understand the need for some sort of over site with respect to animal shelters operating in the state of Hawaii, I believe several parts of this measure are too broad reaching, ambiguous, and lack the details necessary to be a viable bill.

As there seems to be an ever increasing number of shelters appearing Island wide, I firmly believe as a non-profit tax free entity that there should be a level of accountability for them both fiscally and relating to the humane treatment of the animals in their care.

I respectfully recommend the following changes to this bill:

- Remove "boarding kennel" from list of what an "animal rescue entity" is. An "animal shelter" by definition, is a kennel (where dogs are concerned). There are many kennels in Hawaii that accept payment for boarding, and I believe the inclusion of "boarding kennel" could be misconstrued.
- Include "and registered as a 501c for tax purposes" under the "animal rescue entity" definition. This would negate the need for removing "boarding kennel" mentioned above.
- I believe the "enforcing agency" needs to be clarified. If this is our own Hawaiian Humane Society, would this not pose a conflict of interest where other shelters are concerned? While I do not have a problem with HHS being involved, I believe other shelters would definitely have a problem with enforceability of any kind coming from HHS.
- Allowing the "enforcing agency", whoever this is to be, to adopt "any rules or ordinances" is entirely too broad-reaching. We have the Animal Welfare Act which passed some time ago that addresses quality of care for animals and should provide the guidelines for use by the enforcing agency.

• Finally, "a reasonable fee" is very subjective, and should be clarified prior to adopting this measure.
