## SB 826 SD1 – RELATING TO THE PUNA DISTANCE LEARNING CENTER

Chair Tokuda, Vice Chair Dela Cruz and Members of the Committee:

Both the University of Hawai'i at Hilo and the University of Hawai'i Community College System support SB 826 SD1 with suggested revisions to fund a distance learning center in the District of Puna.

There is a critical need to strengthen rural outreach, education and economic development in Puna which is one of the most underserved areas in the state and also the fastest growing district on Hawai'i Island. It would be most feasible and beneficial for the residents of Puna for the Center to be under Hawai'l Community College, with UH Hilo collaborating and partnering to provide higher education and career options to the people of Hawai'i Island.

We would request that the bill be amended to identify Hawai'i Community College as the lead unit, as we are trying to move Hawai'i Community College into being a distributed campus: Hilo, Palamanui, North Hawai'i Education and Research Center and potentially, Puna. Hawai'i Community College is best suited to manage and deliver programs from UH Hilo, Hawai'i CC and other UH campuses as needed.

We support SB 826 SD1 with the above revisions on the condition that any requested funds do not supplant any portion of the University's Biennium Budget request.

Re: Testimony in support of Senate Bill 826 SD1 relating to the Puna Distance Learning Center

Dear Honorable Chair Jill N. Tokuda and members of the Ways and Means Committee,

I urge you to pass Senate Bill 826 SD1 which would appropriate funds for a distance learning center for the Puna district of Hawai'i County. Council district 5 which I represent encompasses the mauka half of Puna. The residents of this district are some of the most disadvantaged in the state. According to the Department of Business, Economic Development & Tourism (DBEDT), 35.2% of persons in the upper Puna census tract are estimated to be living below the federal poverty level in comparison to the Hilo (kahuku-kaumana) census tract where 5.7% of persons are living below the poverty level.

We are the poorest district on the island, with the least infrastructure and the highest population. The Hawai'i County General Plan estimates that by 2020 the Population of Puna will be 58,246 compared to 49,791 in Hilo. The DBEDT estimates that the unemployment rate in the Pahoa cencus tract (in Puna) was 11.5% in 2016 compared to a state average of 3.3%. In order to improve the economy of Hawai'i County and of the state, we need to empower these residents by investing into their future. Creating a distance learning center in Puna will allow more residents to pursue higher education providing them the option to move out of poverty, improve their quality of life as well as make greater contributions to our economy.
