So it's been that long that the DLNR has ignored public cries for help over the situation at the Poho'iki boat ramp, the dangerous mix of people seeking a living fishing, surfers, canoe paddlers, keiki and ever-growing numbers of tourists and the Puna residents trying to get in the water via a one-lane boat ramp in a very narrow access. Most Puna people grew up with infrastructure inherited from the plantations. Minimal state infrastructure since statehood! Easy to ignore these poor rural people down here as they're the furthest from Honolulu. But with Puna's population growing more than any other district in the state for years, isn't it about time Puna got some basic state-provided infrastructure?
