Aloha Chair Keith-Agaran and members of the Committee:

The Department of Hawaiian Home Lands (DHHL) supports this administration measure that adds the offense of criminal trespass onto state lands to the penal code and amends criminal trespass in the second degree to apply to government agricultural property regardless of whether it is fenced, enclosed, or otherwise secured.

Although DHHL's mission "to develop and deliver land to native Hawaiians" is well-known, the lesser known charge "to manage the Hawaiian Home Lands trust effectively" is equally important. Increasingly, this responsibility is demanding a greater share of DHHL's financial and staff resources to address. Of DHHL's total land inventory, nearly two thirds are lands designated as General Agriculture or Conservation/Special District. Most of these lands will remain in DHHL's inventory over the next 20 years with DHHL facing land management issues for this acreage, similar to DLNR and other large private land owners (i.e. trespassing, dumping, fire protection, etc.) This bill will clarify that criminal trespass will apply to all state lands and help DHHL by providing a greater deterrence for illegal activities on state lands.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports this administration bill to protect State lands and offers comments. DHS would like to note that enforcement of trespass onto State lands may impact homeless persons. When enforcement takes place there should be an effort to coordinate with homeless outreach providers. DHS asks the Legislature to support the Governor's Executive Budget requests, combined with enforcement efforts, will help to connect our homeless with services and protect their property. DHS defers to other departments in regard to statutory processes and issues related to enforcement of trespass on state lands.

PURPOSE: The purpose of the measure is to add the offense of criminal trespass onto State lands to the penal code. The measure also amends criminal trespass in the second degree to apply to government agricultural property regardless of whether it is fenced, enclosed, or otherwise secured.

DHS understands the intent of the bill is not to criminalize homelessness, but to address issues related to theft and vandalism on state lands, as well as issues related to public safety. However, the homeless population that resides under or on State highways may take the brunt of the enforcement. In order to protect our Homeless DHS asks that State departments and agencies AN EQUAL OPPORTUNITY AGENCY work with the Governor's Coordinator on Homelessness (Coordinator) to secure and provide appropriate homeless outreach services. Outreach services will help build trust with these individuals and families and encourage them to utilize services, such as Housing First, Rapid Rehousing, or shelter.

In addition to outreach, the Coordinator works with State departments and agencies to address concerns related to property or other items that may be left behind on state lands following the enforcement of trespass laws. This coordination will help to protect the due process rights of homeless persons who may be adversely affected by the enforcement of trespass onto State lands.

Thank you for the opportunity to testify and provide comments on this measure.

SB895 Strong Support From: Connie Mitchell, Executive Director IHS, Institute for Human Services, Inc.

IHS strongly supports this measure that would essentially aid in enforcing trespassing on State lands.

As a homeless advocate, we recognize that homelessness is a state of being that many people are not able to escape due to experiences of hardship, life choices and economic inequities. But how one addresses it is very much a choice and a decision to trespass on someone else's property is not something we can support, especially when shelter space and treatment beds are available.

Our Homeless Outreach teams have also witnessed how people have impacted State lands negatively when they establish long term encampments that give little thought to the disposal of human waste, often polluting waterways and land to the point of creating a public health hazard. Tons of trash litter environments on public lands as a result of homeless encampments. As a nurse, I often fear the outbreak and proliferation of infectious diseases such as cholera or flesh eating bacterial infection under such unsanitary conditions.

The State currently has little ability to enforce Trespassing if fences have not been erected around designated State land. For those who are concerned about criminalizing homeless person's, outreach is currently conducted prior to enforcements, giving people ample time to vacate the premises.

Law enforcement also offers warnings before citing individuals. So it is almost always chronic violators that are finally charged or arrested.

Please support this bill to promote more effective homeless outreach. It has the capacity to motivate people to make different choices about moving forward with healthier choices and the need to face the reality of limited choices in Hawaii if they choose not to engage in work and education.
