Dear Chair Nishihara and Members of the Committee:

The Maui Police Department is in support of S.B. 896, which adds the United States Immigration and Customs Enforcement to the list of federal agencies that may make arrests for certain offenses under state law.

The United States Immigration and Customs Enforcement was initially left off the list of federal agencies granted arrest powers for certain state offenses. This bill will add them to the list while removing Citizenship and Immigration Services, who have no arrest powers.

The working relationship between county, state, and federal law enforcement agencies within the State of Hawaii has always been one of understanding and mutual respect, especially here on the island of Maui.

The Maui Police Department respectfully requests the passage of this bill. Thank you for the opportunity to testify.

Dear Chair Nishihara and Committee Members:

The American Civil Liberties Union of Hawaii ("ACLU of Hawaii") writes in opposition to S.B. 896, which seeks to allow Immigration and Customs Enforcement ("ICE") officers to make arrests under state law.

ICE has a dismal record on civil rights, both nationally and in Hawaii. By authorizing ICE officers to make arrests for low-level public order offenses, S.B. 896 opens the door for federal agents to racially profile those believed to be undocumented immigrants and search them without a warrant. President Trump — who has been vocal in proposing unconstitutional immigration policies — issued an Executive Order reinstating local and state immigration enforcement partnerships, under which local law enforcement officers are deputized to assist in arrests, detentions, and deportations. Legislation such as S.B. 896 invites this partnership, positioning Hawaii as accomplice in practices that are harmful to our communities and antithetical to the values of our state. For these reasons, the ACLU of Hawaii urges the Committee to defer S.B. 896.

SUBJECT: Senate Bill No. 896, Relating to the Power of Arrest

I am Lester Hite, Major of the Legislative Liaison Office of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD supports Senate Bill No. 896, Relating to the Power of Arrest.

The HPD is involved in several law enforcement efforts with our Federal law enforcement partners. This bill seeks to update the list of federal agencies whose special agents are allowed to make arrest for certain offenses covered by the Hawaii Revised Statutes by adding the Immigration and Customs Enforcement (ICE) and removing the Citizen and Immigration Services (CIS) from the list. The ICE is the largest law enforcement investigative branch of the U.S. Department of Homeland Security.

The HPD and all other Hawaii county police departments seek assistance from the ICE to pursue local investigations of violation to state statutes. It is essential for the ICE special agents to have state arrest authority while participating in joint operations with county police departments and state law enforcement agencies.
