## SB 909 SD2 – RELATING TO ENERGY ASSURANCE

Chair Lee, Vice Chair Lowen, and members of the committee:

My name is Richard Rocheleau, Director of the Hawai'i Natural Energy Institute (HNEI) at the University of Hawai'i at Mānoa. While we spend much time in the design of innovative solutions for energy policy and technology necessary to drive Hawaii's clean energy transformation agenda, an often understated objective is to ensure the resiliency, safety and security of Hawaii's critical energy infrastructure. Energy assurance planning for natural and man-made disasters and disturbances remains one of the most important tasks of key energy stakeholders. HNEI supports SB 909 SD2 because it appropriately addresses a number of housekeeping and substantive improvements to Hawaii's statutes regarding fuel storage and response and energy emergency management.

SB 909 SD2 effectively establishes chapter 125C to clarify the State's roles in energy assurance for overseeing all forms of energy shortage, disruption and emergencies. While the existing plan is heavily focused on petroleum, SB 909 provides a broader view that affords residents and critical energy consumers with greater coverage and protection potential.

Also addressed in SB 909 SD2 is a greater alignment of state policies on energy assurance with applicable federal, state, county and private sector energy resources, emergency management and energy assurance plans and programs. It brings stark attention to access and confidentiality of crucial energy data essential for energy assurance and response teams to effectively perform, particularly those with Emergency Support Function #12 (energy) responsibilities. The bill also incorporates recommendations found in the most recent federal Quadrennial Energy Review and other federal and state strategic and operational guidance documents.

Aloha, I am Vern T. Miyagi, Administrator of Hawaii Emergency Management Agency and am testifying in **SUPPORT** of Senate Bill 909, SD2.

Energy resilience continues to be a critical factor in the preparation for, response to, and recovery from any major disaster striking the state of Hawaii. Responding to energy shortfalls after a major disaster in Hawaii is greatly handicapped by our remote location in the Pacific. Restoring and sustaining energy requirements post disaster is a key to response and recovery. This was definitely the case in our response to Hurricane Iniki in 1992. Once sustained power was finally restored and distributed on Kauai, the emergency conditions were significantly mitigated.

This measure will address deficiencies in Hawaii's fuel shortage response and energy emergency (energy assurance) statutes. It shares our objectives of providing policy guidance to DBEDT on preparing for, responding to, recovering from, and mitigating against any actual or potential energy supply disruption or shortage to preserve the State's energy security and to ensure that fuel products and energy resources are made available to emergency services and the public in an orderly, efficient, and safe manner."

Chair Lee, Vice Chair Lowen and Members of the Committee.

The Department of Business, Economic Development and Tourism (DBEDT) **strongly supports** SB 909 SD2, an Administration bill which updates Hawaii's petroleum shortage and energy emergency management (Energy Assurance) statutes, in order to strengthen the State's ability under a Governor-declared state of emergency to reduce or prevent shortages of energy that can cause significant adverse impacts on the economy, environment, public health, and the safety and welfare of the people of Hawaii.

Under current emergency plans, DBEDT is responsible for administering the State's Energy Assurance program and plans. This includes planning, training, and exercising to prepare for, and respond to, energy shortage and disaster events to ensure delivery of the energy needed for critical public services.

The primary authoritative guidance for these functions are the decades-old petroleum shortage statutes. However, these provisions no longer align with government and industry energy emergency best practices. Nor do they adequately enable the State to successfully develop the technical and analytic perspective necessary for situational awareness of the State's energy resources under a state of emergency – a requirement for an effective response.

DBEDT believes that clarity of functional roles and clearly delineated authority for implementation is essential. SB 909 SD2's amendments provide policy guidance to better address exposure to energy supply disruption risk over the next decade.

#### IN SUPPORT OF SB 909, SD2, WITH AMENDMENTS Relating to Energy Assurance

Chair Lee, Vice Chair Lowen, and members of the Committee,

I am Lance Tanaka, Chair of the Hydrocarbon Future & Energy Security Working Group of the Hawaii Energy Policy Forum ("Forum"). The Forum, created in 2002, is comprised of more than 40 representatives from Hawaii's electric utilities, oil and natural gas suppliers, environmental and community groups, renewable energy industry, and federal, state and local government, including representatives from the neighbor islands. Our vision and mission, and comprehensive "10 Point Action Plan" serve as a guide to move Hawaii toward its preferred energy goals.

The purpose of SB 909, SD 2 is to address deficiencies in Hawaii's fuel shortage response and energy emergency statutes.

The Forum supports the need for data-driven policy decisions based on valid and reliable data and, in particular, for preparing and responding to energy supply disruptions or shortages, and for preparing and updating an energy assurance plan to ensure Hawaii's energy security.

However, the bill prescribes provisions in Section 1, § 125C- <u>Confidential information</u> (page 3, beginning with line 11) for protecting information collected by state agencies that differ from existing statute, specifically, §486J-6 and 486J-7, HRS. These provisions were adopted by the Legislature when it created a new reporting requirement at the time it placed a moratorium on the pricing cap on wholesale gasoline, the Petroleum Industry Monitoring and Reporting (PIMAR) program. These provisions were the result of the collaborative work of the petroleum industry, the Hawaii Attorney General's Office and the Hawaii Public Utilities Commission, to protect the industry's information from unwarranted disclosure. SB 909 SD2 should honor those same protections by deleting the provision on confidential information (page 3, line 11-21 through page 4, line 19) and replacing it with the following provisions of §486J-6 and 486J-7, HRS, as follows:

**§486J-6-** <u>Confidential information.</u> (a) Statements provided to the department pursuant to section 486J-3 and the data contained therein shall be deemed confidential and exempt from public disclosure under chapter 92F.

(b) No data or information submitted to the department shall be deemed confidential if it is shown that the person submitting the information or data has made it public.

(c) Unless otherwise provided by law, with respect to data that the commission or department obtained or was provided pursuant to this chapter, neither the commission or department nor any employee of the commission or department may do any of the following:

(1) Use the information furnished or obtained for any purpose other than the purposes for which it is supplied;

(2) Make any publication whereby the data furnished by any person can be identified; or
(3) Permit any person other than the commission, the department of taxation, the attorney general, the consumer advocate, the department of business, economic development, and tourism, and the authorized representatives and employees of each to examine the individual reports or statements provided.

Chair Lee, Vice Chair Lowen, and Members of the Committee on Energy and Environmental Protection, I am Richard Parry, President of the Hawaii Petroleum Marketers Association ("HPMA"). HPMA is a non-profit trade association comprised of members who directly market liquid motor fuel products across the Hawaiian Islands. Our membership includes individuals and companies who operate as independent marketers, jobbers or distributors of petroleum products and who buy liquid motor fuel products at the wholesale level and sell or distribute products to retail customers, other wholesalers, and other bulk consumers. HPMA's primary purpose is to protect and advance its members' legislative and regulatory interests in the Hawaiian Islands and Washington, D.C.

HPMA would like to comment on S. B. No. 909 SD2 which seeks to address deficiencies in Hawaii's fuel shortage response and energy emergency (energy assurance) statutes; provides policy guidance on preparing for, responding to, recovering from, and mitigating against any actual or potential energy supply disruption or shortage to preserve the State's energy security and to ensure that fuel products and energy resources are made available to emergency services and the public in an orderly, efficient, and safe manner.

HPMA is concerned about the ambiguity in the confidentiality provisions currently in S.B. 909 SD2. However, HPMA would support the intent of S.B. 909 SD2 if it adopts the approach for confidentiality found in the Energy Industry Information Reporting Act, in Chapter 486J of the Hawaii Revised Statutes. Specifically, the confidentiality provisions in the existing law read as follows: Testimony of Hawaii Petroleum Marketers Association

**\*§486J-6 Confidential information.** (a) Statements provided to the department pursuant to section 486J-3 and the data contained therein shall be deemed confidential and exempt from public disclosure under chapter 92F.

(b) No data or information submitted to the department shall be deemed confidential if it is shown that the person submitting the information or data has made it public.

(c) Unless otherwise provided by law, with respect to data that the commission or department obtained or was provided pursuant to this chapter, neither the commission or department nor any employee of the commission or department may do any of the following:

(1) Use the information furnished or obtained for any purpose other than the purposes for which it is supplied;

(2) Make any publication whereby the data furnished by any person can be identified; or

(3) Permit any person other than the commission, the department of taxation, the attorney general, the consumer advocate, the department of business, economic development, and tourism, and the authorized representatives and employees of each to examine the individual reports or statements provided.

**§486J-7 Confidential information obtained by another state agency.** Any confidential information pertinent to the responsibilities of the commission or the department specified in this chapter that is obtained by another state agency, including the department of taxation, the attorney general, and the consumer advocate, shall be available only to the attorney general, the attorney general's authorized representatives, the department of business, economic development, and tourism, and the commission and shall be treated in a confidential manner."

### COMMENTS ON SB 909 SD2

Aloha Chair Lee, Vice Chair Lowen, and Committee Members:

Blue Planet Foundation **supports the intent** of this bill, which is to increase the state's energy security. For example, the bill takes the sensible step of shifting the focus from "petroleum" fuels and energy security, and instead focusing energy on a broader spectrum of energy resources.

This transition to away from fossil fuels is Hawai'i's foremost protection against supply disruptions in the global petroleum markets. Thus, the transition to renewable energy should be reflected in the bill. As currently drafted, the bill directs DBEDT to:

- "Develop an understanding of the causes and effects of transitional issues and trends related to changes in the state's energy resources, systems, and markets."
- "Establish and maintain baseline data and information on Hawaii's statewide energy resources, systems, and markets, and their relationships to energy investment decisions and the economy in support of measures to increase energy resiliency, reduce vulnerabilities, and preserve Hawaii's energy security."
- "Produce other relevant energy analyses that the director deems necessary to administer the energy planning, energy emergency planning, energy assurance planning, and energy security policies" in relevant laws.

These steps, if implemented in a vacuum of over-arching policy on the transition to more secure renewable energy, would potentially be a waste of resources. Even more troubling, taking these steps in the absence of such policy could potentially be misguided and ultimately harm the state's energy security. Thus, for SB 909 to have its intended effect, state law must set the policy vision for the transition away from fossil fuels.

For our electricity sector, there is already a state planning target for transitioning to more secure renewable energy (by 2045). For ground transportation, however, there is no such policy target. In support of the intent of SB 909, we propose that the bill should be amended to revise the State Planning Act and set 2045 as the planning target for a ground transportation sector powered by renewable energy.
