I do not feel that SB983 benefits any patient in receiving the care needed by taking away the right of the physician to prescribe medications in care of that injured patient. SB983 is taking away the patients right to receive care from your physician and physicians right to provide that care. I would not have been able to receive to receive total care your medications are managed and available for care when needed.

Just exactly what does SB983 accomplish? Nothing with addiction but instead impede patient's access to medical care and their medications from their attending physician.

There is no scientific evidence--based medicine that limiting a physician from dispensing prescriptions will reduce abuse to addictive painkillers.
