SCR 162 – REQUESTING THE DEPARTMENT OF EDUCATION TO COORDINATE WITH HIGH SCHOOL ASSOCIATIONS AND HIGHER EDUCATION INSTITUTIONS IN HAWAII AND TO PARTNER WITH DEBATE ORGANIZATIONS IN ORGANIZING EVENTS FOR STUDENTS TO DEBATE ON CURRENT ISSUES AFFECTING HAWAII AND THE NATION

Chair McKelvey, Vice Chair Hashem, and members of the committee:

SCR 162 notes that debates and debate events develop skills in speaking and knowledge of public events, and requests the Hawai'i Department of Education work with other groups to organize debates on selected topics at the State Capitol.

The University of Hawai'i (UH) appreciates the benefits of student debate, but does not support the adoption of SCR 162 due to the necessity of additional resources to implement and coordinate a program, and the uncertainly of both the state and federal budget situations at this time. The University defers to the Department of Education on these matters.

Title of Resolution: SCR 162 REQUESTING THE DEPARTMENT OF EDUCATION TO COORDINATE WITH HIGH SCHOOL ASSOCIATIONS AND HIGHER EDUCATION INSTITUTIONS IN HAWAII AND TO PARTNER WITH DEBATE ORGANIZATIONS IN ORGANIZING EVENTS FOR STUDENTS TO DEBATE ON CURRENT ISSUES AFFECTING HAWAII AND THE NATION.

Purpose of Resolution:

Department's Position:

The Department of Education (Department) is unable to support SCR 162, as introduced, which requests the Department to coordinate and organize speech and debate events for public and private school students attending high schools and college. Although the Department encourages student participation in debate events, we lack the resources and capacity to organize and coordinate such events.

The Department could support this resolution with the following amendments:

(1) Changing its title to read: "ENCOURAGING THE DEPARTMENT OF EDUCATION, HIGH SCHOOL ASSOCIATIONS, AND HIGHER EDUCATION INSTITUTIONS IN HAWAII TO PARTNER WITH DEBATE ORGANIZATIONS TO WORK WITH THE HOUSE COMMITTEE ON LEGISLATIVE MANAGEMENT TO PROMOTE EVENTS FOR STUDENTS TO DEBATE ON CURRENT ISSUES AFFECTING HAWAII AND THE NATION.";

(2) Adding a whereas clause after line 23 to read as follows: "WHEREAS, organizations should promote debate events as resources allow; now, therefore," and

(3) Rephrasing lines 26-39 on page 2 to read as follows: "BE IT RESOLVED by the Senate of the Twenty-ninth Legislature of the State of Hawaii, Regular Session of 2017, the House of Representatives concurring, that the Department of Education, Hawaii Association of Independent Schools, Hawaii State Public Charter School Commission, Hawaii Homeschool Association, the University of Hawaii System, Hawaii Pacific University, Brigham Young

MATAYOSHI SUPERINTENDENT University-Hawaii, Chaminade University, Debate Hawaii, and Hawaii Speech League are encouraged to work with the House Committee on Legislative Management to promote events for Hawaii public and private high school students and higher education students to engage in the debate of current and relevant issues, including legislative measures, that affect the State and the Nation; and"
