Senate Concurrent Resolution 49 Relating to Hawaiian Language in Private Schools

Aloha Chair Shimabukuro, Vice Chair Galuteria and Members of the Committee,

The Ka Lāhui Hawaii Political Action Committee (KPAC) supports SCR 49 urging private schools in Hawai'i to consider offering or continue offering Hawaiian language instruction as an option or an elective in their academic curriculum.

Hawaiian Language is the first language of the Hawaiian archipelago and has been an official language of the State of Hawai'i for nearly 40 years. Therefore, it is a travesty that of the 107 private schools in Hawai'i the majority of them fail to offer Hawaiian language instruction or curriculum despite many free resources and learning aids readily available.

There are now approximately 3,000 students enrolled in Hawaiian Immersion schools from pre-k to grade 12 and hundreds more students enrolled in post-secondary Hawaiian Language courses. According to the Kamehameha Schools study "Culture Based Education and Its Relation to Student Outcomes" (2010), culture based education (including Hawaiian Language) have positive outcomes that translate into higher math and reading scores for all students, especially Kanaka Maoli students.

The University of Hawai'i at Mānoa Kawaihuelani school currently offer Bachelor and Master degrees in Hawaiian Language while the University of Hawai'i at Hilo Ka Haka 'Ula o Ke'elikōlani college currently offer Master and PhD degrees in Hawaiian Language creating a viable workforce for the growing need for Hawaiian instruction.

SCR 49 is a first step in raising the status of the native language of the Hawaiian Archipelago, in providing job opportunities for a growing number graduates with college degrees in Hawaiian, and most importantly will raise the overall wellbeing of the Kanaka Maoli people.

Comments: Aloha Hawaiian Affairs Chair Shimabukuro and Members of the Committee, My name is William H. Wilson. I am a faculty member of Ka Haka 'Ula O Ke'elikōlani College of Hawaiian Language at the University of Hawai'i at Hilo and also a member of the Board of the non-profit 'Aha Pūnana Leo. I strongly support the teaching of Hawaiian in the private schools of Hawai'i. Many of the larger private schools of Hawai'i were founded through the agency of ali'i or were greatly aided by bequests from ali'i. What better way to honor those ali'i than to contribute to the maintenance of Hawaiian as a living language and to follow the example of many of those ali'i who spoke, read, and wrote both Hawaiian and English fluently. While not all private schools in Hawai'i were founded by ali'i, all private schools in Hawai'i enroll students who have inherited the legacy of an interethnic society build from a base in the indigenous culture that is most fully expressed through the Hawaiian language. Many non-Native Hawaiian ancestors of the students in our private schools of diverse ethnic backgrounds spoke Hawaiian. Today we all share unique vocabulary terms from Hawaiian that connect us to the land, flora and fauna of these islands as well as to customs such as lei giving that are tied to the Hawaiian language, an official language of our state. While I am not officially representing Ka Haka 'Ula O Ke'elikolani College of Hawaiian Language or the 'Aha Pūnana Leo, I note that both entities have already established means to support the learning of Hawaiian including the resources of Ulukau and various publications and videos. Those are available to the private schools as well as to the public schools as will be future resources. There is much available today to support the study of Hawaiian. I strongly support the teaching of Hawaiian in all schools of Hawai'i, both public and private and sincerely appreciate this important resolution.
