1 WHEREAS, according to data mined from the State Procurement 2 Office website, it appears that only three percent of state 3 contracts are awarded to women-owned architectural and 4 engineering firms located in Hawaii; and 5

6 WHEREAS, despite the Department of Transportation
7 Disadvantaged Business Enterprise Program, women-owned firms in
8 Hawaii continue to face disparate treatment in the awarding of
9 state contracts; and

11 WHEREAS, according to the Society of Women Engineers, close 12 to twenty percent of engineering school graduates are women, but 13 less than fourteen percent of engineers in the workforce are 14 women, and according to data from the Society of Women Engineers 15 and the National Science Foundation, women are more likely than 16 men to leave engineering as their careers progress; and 17

18 WHEREAS, the National Academies of Sciences, Engineering 19 and Medicine concluded in their Beyond Bias and Barriers report 20 released in 2007 that women are very likely to face 21 discrimination in the engineering field; and 22

WHEREAS, according to the Association of Collegiate Schools
 of Architecture, over forty percent of architecture degrees are
 awarded to women, but only twenty-five percent of architect and
 architectural designers in the workforce are women; and

1 WHEREAS, data is currently unavailable regarding the 2 overall percent of state contracts awarded to women-, veteran-, 3 or Native Hawaiian-owned businesses in Hawaii, but in all 4 likelihood these businesses face challenges in procuring state 5 contracts and are underrepresented in the state procurement 6 process; and

8 WHEREAS, women-, veteran-, and Native Hawaiian-owned 9 businesses in Hawaii must be given proper consideration and 10 equal opportunity for procuring state contracts if women-, 11 veteran-, and Native Hawaiian-owned business are to succeed and 12 achieve fair representation in the workforce; now, therefore, 13

BE IT FURTHER RESOLVED that the Department of Transportation, Department of Accounting and General Services, Department of Education, and University of Hawaii System are requested to submit to the Legislature, no later than October 1, 2017, a list of state contracts under their department or agency awarded to women-, veteran-, and Native Hawaiian-owned businesses in the last two years; and 30

#### House Committee on Labor and Public Employment

The Hawaii Department of Transportation (DOT) **supports** S.C.R. 59, S.D.1 which encourages state departments and agencies to duly consider women-owned businesses when awarding state contracts.

DOT administers the Disadvantaged Business Enterprise (DBE) program which provides opportunities for women-owned firms to participate on federal-aid contracts. Honorable Chair Johanson and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 350 members. On behalf of our members, we offer this testimony in strong support of SCR 59, SD 1, urging all state departments and agencies to duly consider women-, veteran-, and Native Hawaiian-owned businesses when awarding state contracts, and requesting all state departments and agencies to submit to the legislature a list of state contracts awarded in the last two years to women-, veteran-, and Native Hawaiian-owned businesses.

According to the Society of Women Engineers, roughly 20 percent of engineering school graduates are women. Yet, women comprise less than 14 percent of the engineering workforce. Research performed by the consulting firm McKinsey and Company likewise found that for U.S. Corporations, the career pipeline is inequitable for females, with the underrepresentation of women increasing and accelerating as the level of professional leadership becomes greater (see below).

Some states, like New York, are addressing this problem by establishing certifications for "Minority and Women-Owned Business Enterprises," which can be easily identified by and interact with state agencies. The New York State Contract System's Division of Minority and Women's Business Development focuses on promoting equality of economic opportunities for MWBEs and eliminating barriers to their participation in state contracts.

Gender inequality linger in the islands, too, where women earn 83 cents on the male dollar, a pay gap that will persist until at least the year 2058 if public policy does not change, according to the Hawai'i Commission on the Status of Women. Indicators of inequality are also indicators of the extent to which gender disparity is being resolved socially, as discourses that undergird female disempowerment–destructive myths about women's weakness, emotionality, or inability to perform male-dominated jobs involving math and science, for example–continue to circulate.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SCR59, which seeks to support women, veteran, and Native Hawaiian-owned businesses.

One of OHA's strategic priorities is Ho'okahua Waiwai, or increasing the economic self-sufficiency of Native Hawaiians. This includes supporting Native Hawaiian-owned business development. As such, OHA's programs include Hua Kanu loans, one of the products offered through the OHA-administered Native Hawaiian Revolving Loan Fund (NHRLF), which was originally funded through the federal Administration of Native Americans. Hua Kanu loans provide low-interest rate loans of up to \$1 million, for highly qualified and established Native Hawaiian business owners. NHRLF's other loan program, the Mālama Loan, provides loans of up to \$100,000 to Native Hawaiian beneficiaries to start or expand a business.

Urging state agencies to duly consider businesses owned by Native Hawaiian and other under-represented groups is another important way that our state can help support the economic development and self-sufficiency of minority communities. Currently, Hawai'i does not incentivize awarding contracts to businesses owned by underrepresented groups, including Native Hawaiian-owned businesses. In contrast, the federal government itself has long-standing policies and practices that recognize the unique value and need to provide procurement opportunities for Native Hawaiian-owned businesses. For example, in 1988, Congress passed Public Law 100-656, which amended the Small Business Act of 1953 Section 8(a) to include certain Native Hawaiian-owned businesses in contracting opportunities available to tribally-owned corporations and Alaska Native corporations. Numerous subsequent Acts of Congress have reaffirmed the federal government's acknowledgement of the value of actively working to ensure that Native Hawaiian Organization-owned and other Native Hawaiian-owned businesses have appropriate opportunities to participate in government contracts. We hope that this resolution will help the State of Hawai'i move towards similar policies, for the benefit of Native Hawaiians and the general public.

OHA notes that it operates an active Hawaiian Registry Program, which is able to verify the Native Hawaiian ancestry of interested individuals. OHA offers this program as one potential means of verifying business owners as Native Hawaiian, should the State move forward with contract procurement policies that provide opportunities for Native Hawaiian-owned businesses specifically.

OHA therefore urges the Committee to **PASS** SCR59. Mahalo nui for the opportunity to testify on this measure.
