**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) appreciates the intent and supports the resolution.

**PURPOSE:** The purpose of Senate Continuing Resolution 76 is to request that healthcare providers and health plans gather data regarding the use of publicly funded medical assistance programs by persons experiencing homelessness by using the ICD-10 diagnoses codes for homelessness when they are medically indicated. The State is requested to work with healthcare providers and health plans to increase awareness and promote the appropriate use of the ICD-10 diagnoses codes; and to use data regarding the utilization of healthcare by homeless individuals to explore creative and innovative solutions to address homeless individuals' healthcare needs.

As the resolution notes, homelessness is a critical societal issue that has far-reaching effects. It is also well-known that chronically homeless individuals suffer from many complex health conditions that cannot be addressed without housing, and vice versa, the individuals are

unable to obtain and retain housing without the social and health wrap-around supports of health related permanent supportive housing.

It is also clear that the need for data from various sectors is essential not only for the immediate case management and health needs of the individuals who are homeless, but also for evaluation, analysis and to enable insights that can be used to design innovative solutions.

The use of the ICD-10 diagnoses codes is one method that can be used to gather more comprehensive information on the health needs of homeless individuals. This can be used to create a more detailed and comprehensive picture of the health conditions as well as the healthcare resources being used to treat individuals who are homeless. Additionally, the information can be useful to evaluate different innovative and creative solutions that our community can bring to bear to help address this serious issue plaguing our state.

**POSITION**: The Governor's Coordinator on Homelessness supports this resolution.

**PURPOSE**: The purpose of this resolution is to request that healthcare providers and health plans utilize the ICD-10 diagnoses codes for homelessness to gather data regarding the use of publicly funded medical assistance programs by persons experiencing homelessness. The resolution also requests the state to work with healthcare providers and health plans to increase awareness of the ICD-10 codes.

While the ICD-10 diagnosis classification system includes diagnoses codes for homelessness (Z59.0) and housing instability (Z59.1), these codes are rarely used by hospitals. Increased utilization of these codes by hospitals and healthcare providers will result in more complete data to inform policy and the allocation of resources to address homelessness.

The Coordinator is committed to working together with the Department of Health (DOH) and Department of Human Services (DHS) to use available healthcare utilization data to explore creative and innovative solutions to address homelessness. Currently, there are a number of efforts already underway to address the critical intersection between healthcare and homelessness. For example, the DHS Med-QUEST Division is currently pursuing an amendment to its 1115 Medicaid waiver, which would expand eligibility for case management and supportive services for Medicaid-eligible individuals that are identified as chronically homeless. The increased use of data available through better use of the ICD-10 codes will enable similar collaborative and innovative efforts to address the needs of individuals experiencing homelessness.
