#### **Department's Position:**

The Department of Education (Department) strongly supports SCR009, expressing support of the Department of Education's work to better engage community groups in the education of children and youth in Hawaii's public schools.

The Community Engagement Office (Office) was formally established in August 2016, and serves as a coordinating entity both within the Department, and external to the Department for partnerships and collaboration.

Functionally, the Office aims to be a source of guidance and training for schools; and houses growing networks of partners that support out of school time, and health and well-being. Hawaii Youth Services Network, a statewide coalition of youth-serving organizations, supports SCR 137/SR 58 Requesting the Board of Education to Consider Requiring Students in Grades Six, Seven and Eight to Take Courses in Physical Education and Health Education.

Lifestyle choices, including regular exercise, healthy eating, and avoiding risky behaviors, strongly influence one's health throughout the life time. Engaging in regular exercise in school makes it more likely that students will sustain healthy exercise throughout their lifetime, and avoid heart disease, diabetes, and other chronic health conditions. Children and youth participate in health education programs that address substance use, sexual health, and other risky behaviors in the middle school, are less likely to experience drug use, unplanned pregnancy and sexually transmitted infections, or become involved in motor vehicle accidents.

Students who are physically fit and prepared to make good decisions about their health are more likely to succeed academically, graduate from school, and make positive transitions to adulthood.

The Native Hawaiian Education Council (NHEC or the Council) <u>SUPPORTS</u> SCR 9 based on our:

- A. **Support of the Legislature's actions** in: 1) Acknowledging the value of family and community engagement in Hawai'i's public education system; 2) Acknowledging the State Educational Agencies (SEA) responsibilities to family and community in the federal Every Student Succeeds Act (ESSA); 3) Valuing private-public partnerships in public education; 4) Highlighting the many community organizations that are willing and able to support families and communities; and 5) Recognizing the need to provide safe school environments for in and after school activities and services providing both academic and health supports.
- B. **Platform and priorities to: Amplify Family and Community Voices** by advocating for the effective implementation of ESSA for the benefit of families and communities; and aggregating field data on family and community voices by island community.

In urging the Department of Education "..to carry on its work to better engage community groups in the education of children and youth in Hawai'i's public schools..", the Council calls to the Legislature and Department of Education attention, the need to fully fund the Office of Community Engagement (OCE, under the Superintendent's office) in order to coordinate more effectively such engagement with community groups.
