## A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that Hawaii has the
3	highest rate per capita of homelessness of any state in the
4	nation. Hawaii also has the highest rate per capita of
.5	chronically unsheltered homeless of any state. The 2016 point
6	in time count found an estimated 7,921 people living on the
7	streets and in shelters in Hawaii. These statistics indicate a
8	four per cent increase overall in the total number of homeless
9	and a twelve per cent increase in the number of unsheltered
10	individuals and families since 2015.
11	The legislature also finds that addressing homelessness
12	requires a multi-faceted approach using interventions targeted
13	to the particular characteristics of the population being
14	served. The legislature believes that outreach is a critical
15	part of this multi-faceted approach. A more strategic,
16	coordinated outreach effort is needed to assertively serve the
<b>17</b>	growing percentage of homeless persons who are not living in
18	shelter programs. As the State and counties increase

- 1 enforcement efforts in parks and public areas, outreach to
- 2 homeless persons becomes even more significant. Outreach to the
- 3 special populations of the mentally ill and substance abusers is
- 4 also critical to ending homelessness. Programs such as the law
- 5 enforcement assisted diversion pilot project assists unsheltered
- 6 persons experiencing substance abuse for whom probable cause for
- 7 arrest exists, by diverting these low-level offenders from
- 8 booking and redirecting them to community-based treatment and
- 9 support services.
- 10 The legislature further finds that unaccompanied homeless
- 11 youth are often hard to locate and identify and are particularly
- 12 vulnerable to exploitation. Between 2000 and 2010, over thirty
- 13 per cent of all juvenile detainments in Hawaii were for running
- 14 away from home. Outreach is especially critical to help newly
- 15 homeless youth navigate the social services system to find safe
- 16 alternatives to homelessness. Youth service providers report
- 17 that the number of homeless youth has been increasing each year.
- 18 The legislature believes that the State needs to address youth
- 19 homelessness to prevent these homeless youth from becoming
- 20 homeless adults.

- 1 The purpose of this Act is to appropriate funds to the
- 2 department of health and the department of human services,
- 3 including the office of youth services, to provide homeless
- 4 outreach services.
- 5 PART II
- 6 SECTION 2. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 8 thereof as may be necessary for fiscal year 2017-2018 and the
- 9 same sum or so much thereof as may be necessary for fiscal year
- 10 2018-2019 for outreach to homeless persons with serious and
- 11 persistent mental illness.
- 12 The sums appropriated shall be expended by the department
- 13 of health for the purposes of this part.
- 14 PART III
- SECTION 3. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$800,000 or so much
- 17 thereof as may be necessary for fiscal year 2017-2018 and the
- 18 same sum or so much thereof as may be necessary for fiscal year
- 19 2018-2019 for outreach, counseling, and diversion for homeless
- 20 unsheltered persons experience substance abuse; provided that

- 1 \$200,000 shall be used for the law enforcement assisted
- 2 diversion pilot project.
- 3 SECTION 4. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$1,200,000 or so much
- 5 thereof as may be necessary for fiscal year 2017-2018 and the
- 6 same sum or so much thereof as may be necessary for fiscal year
- 7 2018-2019 for additional outreach to homeless individuals and
- 8 families with children.
- 9 SECTION 5. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$500,000 or so much
- 11 thereof as may be necessary for fiscal year 2017-2018 and the
- 12 same sum or so much thereof as may be necessary for fiscal year
- 13 2018-2019 for civil legal services for homeless persons.
- 14 The sums appropriated by this part shall be expended by the
- 15 department of human services for the purposes of this part.
- 16 PART IV
- 17 SECTION 6. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$300,000 or so much
- 19 thereof as may be necessary for fiscal year 2017-2018 and the
- 20 same sum or so much thereof as may be necessary for fiscal year
- 21 2018-2019 for outreach to unaccompanied homeless youth.
