Pursuant to Act 242, relating to Uniform Information Practices, during 2017, the Maui Police Department sustained one charge of misconduct for incidents of:


- Mistreatment of a prisoner / arrested person

- The discipline imposed may be appealed and subsequently amended as a result of the SHOPO Collective Bargaining Agreement grievance process.
