ORIGINAL ACT 164 H.B. NO. 50.2

A BILL FOR AN ACT

RELATING TO NON-GENERAL FUNDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to abolish various
- 2 non-general funds and accounts pursuant to the recommendations
- 3 by the auditor in auditor's report no. 17-10 and to transfer the
- 4 unencumbered balances to the general fund.
- 5 SECTION 2. The est/adm license and permit tobacco and
- 6 cigarette special fund is abolished and any remaining
- 7 unencumbered balance shall lapse to the general fund.
- 8 SECTION 3. The IRS refund intercept trust account is
- 9 abolished and any remaining unencumbered balance shall lapse to
- 10 the general fund.
- 11 SECTION 4. The special enforcement section collections
- 12 trust account is abolished and any remaining unencumbered
- 13 balance shall lapse to the general fund.
- 14 SECTION 5. The taxes payable to counties fuel trust
- 15 accounts are abolished and any remaining unencumbered balances
- 16 shall lapse to the general fund.
- 17 SECTION 6. This Act shall take effect on July 1, 2018.
