A BILL FOR AN ACT

RELATING TO RESOURCE RECOVERY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the department of

2 education produces a large amount of rubbish and waste from two

3 hundred sixty-five schools across the State, which significantly

4 impacts the State's environment and finances.

5 The legislature further finds that on-site campus

6 composting programs involving students have been extremely

7 successful in providing a beneficial method of waste diversion.

8 These programs foster learning about scientific principles and

9 social practices while allowing students to take responsibility

10 for the amount of waste generated.

11 The legislature believes that a demonstration of the

12 effectiveness of on-site campus composting allows students to

13 see the relationships between food waste, composting, nutrient

14 cycling, healthy soils, and local food production. This is a

15 natural extension of the legislature's commitment to increasing

16 garden- and farm-based opportunities and is one of five pillars

17 of the department of agriculture's Hawaii farm to school

18 program, established by Act 218, Session Laws of Hawaii 2015.

- 1 Proper guidance from the departments of health and agriculture
- 2 regarding campus composting would increase the safety of
- 3 existing programs while expanding opportunities for new programs
- 4 in state schools.
- 5 The legislature finds that developing a statewide model for
- 6 on-site campus composting provides a way to reach the Aloha+
- 7 Challenge waste reduction goals, increase local food production,
- 8 and promote natural resource management.
- 9 Accordingly, the purpose of this Act is to authorize the
- 10 department of education to establish composting grant pilot
- 11 projects in department of education schools to:
- 12 (1) Address opportunities for waste diversion;
- 13 (2) Engage students to learn about different composting
- methods:

21		vermicast tea for soil amendments;

 5 regarding the issuance of grants to schools pursuant

- 7 (d) The composting grant pilot project working group shall
 8 elect one of its members to serve as its chair.
- 9 (e) The composting grant pilot project working group shall
 10 be administratively attached to the department of education,
 11 which shall provide support staff for the composting grant pilot
 12 project working group.
- (f) Members of the composting grant pilot project working group shall serve without compensation but shall be reimbursed for reasonable expenses, including travel expenses, incurred during the performance of their duties.
- 17 (g) No member of the composting grant pilot project
 18 working group shall be made subject to chapter 84, Hawaii
 19 Revised Statutes, solely because of that member's participation
 20 on the composting grant pilot project working group.

- 1 (h) The composting grant pilot project working group shall
- 2 submit a report to the legislature with its findings and
- 3 recommendations no later than twenty days prior to the convening
- 4 of the regular session of 2019 and each regular session
- 5 thereafter.
- 6 (i) The department of education shall adopt rules,
- 7 pursuant to chapter 91, Hawaii Revised Statutes, to implement
- 8 the composting grant pilot project.
- 9 (j) The department of agriculture's farm to school
- 10 program, established by section 141-11, Hawaii Revised Statutes,
- 11 shall provide oversight of the composting grant pilot project.
- 12 (k) Any school that is a recipient of a grant issued
- 13 pursuant to this Act shall pay a portion of the initial
- 14 operating costs of a composting grant pilot project using either
- 15 its elective funds or any applicable fundraising proceeds, as
- 16 prescribed by rules adopted pursuant to subsection (i).
- 17 SECTION 3. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$300,000 or so much
- 19 thereof as may be necessary for fiscal year 2018-2019 to
- 20 establish and implement the composting grant pilot project.

- 1 The sum appropriated shall be expended by the department of
- 2 education for the purposes of this Act.
- 3 SECTION 4. This Act shall take effect on July 1, 2018.
