A BILL FOR AN ACT

RELATING TO TIER II FILING FEES FOR REPORTING OF HAZARDOUS SUBSTANCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to increase the
- 2 Hawaii Emergency Planning and Community Right-to-Know (HEPCRA)
- 3 Act, Tier II filing fee from \$100 to \$200. In fiscal year 2014-
- 4 2015, 889 total facilities (civilian and military) paid \$68,300
- 5 in filing fees. These moneys are collected pursuant to section
- 6 128E-9, Hawaii Revised Statutes, and are deposited into the
- 7 environmental response revolving fund.
- 8 The Tier II filings fees are used by the county local
- 9 emergency planning committees to conduct joint emergency
- 10 planning response training, to purchase specialized equipment,
- 11 and for hazardous materials emergency preparedness activities.
- 12 As HEPCRA operational and equipment costs have risen over the
- 13 years it is necessary to increase the fee to maintain the
- 14 emergency preparedness and response capabilities of the county
- 15 first responders that respond to hazardous materials incidents
- 16 statewide.

3	"§128E-9 Filing fees. Facilities that are required to
4	report according to section 128E-6(a)(2), shall remit [\$100]
5	\$200 with each submission of chemical inventory forms or Tier II
6	forms to the commission by March 1 of each year. All moneys
7	collected by the department pursuant to this section shall be
8	deposited in the state treasury and accrue to the credit of the
9	environmental response revolving fund established in section
10	128D-2."

12	and stricken. New statutory material is underscored.
13	SECTION 4. This Act, upon its approval, shall take effect

TITLE: A BILL FOR AN ACT RELATING TO TIER II FILING

FEES FOR REPORTING OF HAZARDOUS SUBSTANCES.

PURPOSE: To raise the Hawaii Emergency Planning and

Community Right-To-Know Act (HEPCRA) annual

Tier II filing fee from \$100 to \$200.

MEANS: Amend section 128E-9, Hawaii Revised

Statutes (HRS).

JUSTIFICATION: The HEPCRA law was enacted in 1993 and

requires that covered facilities submit an annual Tier II chemical inventory form and pay a \$100 filing fee on March 1 of each year. In fiscal year 2014-2015, 889 total facilities (civilian and military) paid \$68,300 in filing fees. The moneys collected are pursuant to section 128E-9,

HRS, and are deposited into the

environmental response revolving fund.

The Tier II filings fees are used by the county local emergency planning committees (LEPC)s to conduct joint emergency planning response training, purchase specialized equipment, and for hazardous materials emergency preparedness activities. As HEPCRA operational and equipment costs have risen over the years it is necessary to raise the current fee from \$100 to \$200 in order to maintain the emergency preparedness and response capabilities of the county first responders that respond to hazardous materials incidents statewide.

Impact on the public: Hawaii has approximately 900 Tier II reporting businesses in local communities statewide who will be affected. The fee increase provides needed resources to LEPCs serving those communities, providing community



preparedness and safety during chemical emergencies associated with the Tier II business operations and other hazards.

Impact on the department and other agencies:
Adequate funding for LEPCs is a cornerstone
of effective interagency emergency
coordination and response at the local
level. Successful LEPC engagement with the
Hawaii State Emergency Response Commission
(HSERC) ensures effective statewide

emergency preparedness.

GENERAL FUND: None.

OTHER FUNDS: Projected increase of approximately \$75,000

per year into the Environmental response

revolving fund.
