### A BILL FOR AN ACT

RELATING TO CRIME VICTIM COMPENSATION FOR MENTAL HEALTH SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 351-31, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: 3 "(a) In the event any private citizen is injured or killed 4 by any act or omission of any other person coming within the 5 criminal jurisdiction of the State after June 6, 1967, or any 6 state resident is injured or killed by any act or omission of 7 any other person after July 1, 1989, in another state, which act 8 or omission is within the description of the crimes enumerated 9 in section 351-32, or any resident of this State who is injured 10 or killed by an act of terrorism occurring outside the United 11 States, as defined in title 18 United States Code section 2331, 12 the commission in its discretion, upon an application, may order 13 the payment of compensation in accordance with this chapter: 14 (1)To or for the benefit of the victim: 15 (2)To any person responsible for the maintenance of the 16 victim, if that person has suffered pecuniary loss or

Crime Victim Compensation for Mental Health Services

#### Description:

Authorizes crime victim compensation for mental health services for survivors in cases involving a death and for children who witness domestic violence.

DEPARTMENT:	Public Safety
TITLE:	A BILL FOR AN ACT RELATING TO CRIME VICTIM COMPENSATION FOR MENTAL HEALTH SERVICES.
PURPOSE:	To provide compensation for mental health counseling services for: (1) Surviving relatives in a case involving the death of the victim; and (2) Child witnesses in a case involving domestic violence.
MEANS :	Amend sections 351-31(a) and 351-33, Hawaii Revised Statutes.
JUSTIFICATION:	Mental Health Counseling for Surviving Relatives in a Case Involving Violent Death The Crime Victim Compensation Commission (Commission) is unable to provide compensation for mental health counseling services for surviving relatives in a case involving the violent death of a family member. Surviving relatives of murder and negligent homicide are severely traumatized and need access to mental health counseling services in order to heal from the trauma of losing a family member in a violent crime incident.

### Mental Health Counseling for Child Witnesses of Domestic Abuse

The Commission is unable to provide compensation for mental health counseling services for children who witness domestic violence. In 2000, the Department of the Attorney General released a study looking at the impact of domestic violence on children and their victim-mothers. The study found that over half of the children who witnessed domestic violence against their mothers suffered symptoms of post-traumatic stress disorder. The study recommended, among

other things, that children who witness domestic violence have access to effective mental health intervention.

<u>Impact on the public:</u> Providing compensation for mental health services for surviving relatives and child witnesses of domestic violence will help mitigate the impact of violent crime in our community.

Impact on the department and other agencies: None. The proposed amendment does not increase the maximum compensation award per crime. The proposed provision provides that compensation paid on behalf of a deceased victim or domestic violence victim, shall have priority over payment for mental health counseling services to a surviving relative or child witness.
