# A BILL FOR AN ACT

RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS TO ASSIST MAUI ALL NATURAL ALTERNATIVE, LLC.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Maui All Natural
- 2 Alternative, LLC, proposes to build a privately-financed project
- 3 to provide municipal sludge processing and renewable energy at
- 4 the Wailuku-Kahului wastewater reclamation facility on Maui.
- 5 The services provided are in the public interest and address
- 6 various state mandates on solid waste and renewable energy. The
- 7 renewable fuel to power the facility will come through promotion
- 8 of local agricultural activity, which has significantly
- 9 diminished in recent years due to the closing of active
- 10 plantations. The sludge processing services are designed to
- 11 convert municipal sludge into a beneficially reusable product.
- 12 The facility will also create jobs and commercially demonstrate
- 13 the use of agriculture for a sustainable future on Maui and in
- 14 the State.
- 15 The legislature further finds that the county of Maui
- 16 selected Maui All Natural Alternative, LLC, to provide the

- 1 aforementioned services after a competitive bidding process.
- 2 The facility will be sited on the Wailuku-Kahului wastewater
- 3 reclamation facility property under a lease with the county of
- 4 Maui. The project will also return to agriculture approximately
- 5 five hundred acres of former sugar cane agricultural lands
- 6 located in central Maui. Energy crops will be harvested to
- 7 provide clean renewable gas for the generation of firm renewable
- 8 energy and processing municipal sludge.
- 9 The legislature additionally finds that the facility will
- 10 provide valuable operational knowledge and future pathways for
- 11 large scale projects, which can assist in fulfilling Hawaii's
- 12 sustainability goals associated with environmental protection,
- 13 renewable energy, energy security, and promotion of agriculture.
- 14 The legislature also finds that the benefits of the
- 15 development of this facility include the following:
- 16 (1) Reduction of up to six thousand eight hundred tons of
- greenhouse gas emissions per year, with a potential
- for future reduction of 1,500,000 tons of greenhouse
- 19 gas emissions;
- 20 (2) Reduction of up to twenty-four thousand tons of sewage
- 21 sludge for beneficial reuse; and

1	(3) Initial creation of approximately ten to fifteen
2	permanent jobs, with the potential to create up to two
3	hundred new jobs.
4	Finally, the legislature notes that the development of the
5	project contributes to the State and county of Maui's mandates,
6	enables the use of private funding for a public purpose project,
7	and does not present an operational or financial risk to the
8	State or the county of Maui.
9	The legislature finds and declares that the issuance of
10	special purpose revenue bonds under this Act is in the public
11	interest and for the public health, safety, and general welfare.
12	SECTION 2. Pursuant to part V, chapter 39A, Hawaii Revised
13	Statutes, the department of budget and finance, with the
14	approval of the governor, is authorized to issue special purpose
15	revenue bonds in a total amount not to exceed \$ , in one
16	or more series, for the purpose of assisting Maui All Natural
17	Alternative, LLC, a Hawaii foreign limited liability
18	corporation, for development, financing, and construction of a
19	project to provide municipal sludge processing and renewable
20	energy at Wailuku-Kahului wastewater reclamation facility in the
21	county of Maui. The legislature hereby finds and determines

- 1 that Maui All Natural Alternative, LLC's development, financing,
- 2 and construction of a project to provide municipal sludge
- 3 processing and renewable energy constitute a project as defined
- 4 in part V, chapter 39A, Hawaii Revised Statutes, and the
- 5 financing thereof is assistance to an industrial enterprise.
- 6 SECTION 3. The special purpose revenue bonds and the
- 7 refunding special purpose revenue bonds issued under this Act
- 8 shall be issued pursuant to part V, chapter 39A, Hawaii Revised
- 9 Statutes, relating to the power to issue special purpose revenue
- 10 bonds to assist industrial enterprises.
- 11 SECTION 4. The department of budget and finance is
- 12 authorized, from time to time, including times subsequent to
- 13 June 30, 2022, to issue special purpose revenue bonds in
- 14 whatever principal amounts the department shall determine to be
- 15 necessary to refund the special purpose revenue bonds authorized
- 16 in section 2 and to refund special purpose revenue bonds
- 17 authorized in this section, regardless of whether the
- 18 outstanding special purpose revenue bonds or refunding special
- 19 purpose revenue bonds have matured or are the subject of
- 20 redemption or whether the refunding special purpose revenue
- 21 bonds shall be bonds for the multi-project programs described in

- 1 section 2. In making this determination, the department shall
- 2 comply with federal law relating to the exemption from federal
- 3 income taxation of the interest on bonds of the nature
- 4 authorized by this section.
- 5 SECTION 5. The authorization to issue special purpose
- 6 revenue bonds under this Act shall lapse on June 30, 2022.
- 7 SECTION 6. This Act shall take effect on January 28, 2081.
