A BILL FOR AN ACT

RELATING TO ALTERNATIVE HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds the supply of affordable 2 housing in Hawaii does not sufficiently meet demand. Manv 3 financially vulnerable residents are homeless or at risk of 4 becoming homeless. The shortage of affordable housing will not 5 be eliminated solely upon subsidies from the government. The legislature further finds that there is a need for alternative 6 7 solutions in battling the affordable housing shortage, including 8 help from the private sector.

9 Accordingly, the purpose of this Act is to allow counties 10 to grant zoning exemptions for alternative dwellings and 11 alternative dwelling parks that can be built by private parties. 12 SECTION 2. Section 46-1.5, Hawaii Revised Statutes, is 13 amended by amending subsection (14) to read as follows: 14 (14)Each county shall have the power to: 15 (A) Make and enforce within the limits of the county 16 all necessary ordinances covering all: 17


