A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act shall be known and may be cited as the
- 2 "Fair Share Health Care Disclosure Act".
- 3 SECTION 2. The legislature finds that public assistance
- 4 programs are essential to ensuring that all residents have
- 5 access to healthy food, quality health insurance, basic needs,
- 6 cash assistance, child care, and income supports. These
- 7 programs have helped millions of individuals to rise out of
- 8 poverty.
- 9 The legislature further finds that some employers have
- 10 abused public assistance programs by providing their employees
- 11 with low wages and poor benefits with the intention or
- 12 expectation that the employees will enroll in public assistance
- 13 programs to subsidize their income. Nationwide, this business
- 14 strategy costs taxpayers billions of dollars per year and puts
- 15 responsible businesses at a competitive disadvantage. For
- 16 example, more than sixty per cent of enrollees in medicaid and

- 1 the children's health insurance program are members of working
- 2 families.
- 3 The legislature believes that large, profitable employers
- 4 should pay wages and benefits that do not impoverish workers or
- 5 shift costs to taxpayers.
- 6 The purpose of this Act is to require the department of
- 7 human services to compile data and identify employers that have
- 8 numerous employees enrolled in public assistance programs so
- 9 that the legislature and other policy makers will have a deeper
- 10 understanding of the causes and sources of underemployment,
- 11 poverty wages, and the economic impacts on society, business,
- 12 and the state budget.
- 13 SECTION 3. Chapter 346, Hawaii Revised Statutes, is
- 14 amended by adding a new section to part I to be appropriately
- 15 designated and to read as follows:
- 16 "§346- Fair share health care disclosure; report. (a)
- 17 The department shall compile data regarding employers having
- 18 employees who receive public assistance, including benefits
- 19 under the state medicaid program and other services or other
- 20 benefits administered by the department by reviewing employment
- 21 information submitted to the department by recipients. The
