

A BILL FOR AN ACT

RELATING TO MEMORIALS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The freedom and security that United States citizens enjoy today are direct results of the sacrifices and 2 continued vigilance of the United States armed forces over the 3 course of our nation's history. The sacrifices of the members 4 5 of the United States armed forces have preserved the liberties that have made this nation unique in the world community. 6 While members of the United States armed forces have 7 engaged in numerous conflicts worldwide for over two centuries, 8 more recent combat missions have included: 9 The Persian Gulf War, from August 2, 1990, to February 10 (1) 28, 1991, which culminated in the liberation of Kuwait 11 12 from Iraq; The air-and-land conflict known as Operation Desert 13 (2) Storm, which began on January 17, 1991, and lasted 14 through April 11, 1991; 15 Operation Iraqi Freedom, which was a military campaign 16 (3)

that was led by United States troops and conducted

1		from March 20, 2003, through August 31, 2010, and
2		later re-named "Operation New Dawn";
3	(4)	Operation Enduring Freedom, more commonly known as the
4		"War in Afghanistan", which is an ongoing effort; and
5	(5)	Combined Joint Task Force - Operation Inherent Resolve
6		(CJTF-OIR), which is an ongoing military operation led
7		by the United States that aims to "degrade and
8		destroy" the Islamic State of Iraq and the Levant
9		(ISIL).
10	Members of the United States armed forces have also served a	
11	pivotal role in the Global War on Terrorism, Homeland Defense,	
12	and Operation Noble Eagle, and continue to protect our borders	
13	by land, sea, and air.	
14	Recognition of the sacrifices of the United States armed	
15	services members, many of whom paid the ultimate sacrifice, can	
16	be found throughout the State. Two of the most prominent of	
17	these memorials are the USS Arizona Memorial and the National	
18	Memorial Cemetery of the Pacific at Punchbowl. However, a	
19	number of additional memorials exist commemorating the	
20	sacrifices of the men and women in uniform from Hawaii who have	
21	served this country, including the Korean and Vietnam War	

- 1 Memorials on the grounds of the state capitol, which were
- 2 dedicated in 1994. Thus, it is both fitting and necessary for
- 3 the State to give tangible and visible recognition for the
- 4 sacrifices and contributions of veterans from Hawaii who served
- 5 in the Persian Gulf War, Operation Desert Storm, Operation Iraqi
- 6 Freedom, Operation Enduring Freedom, Operation New Dawn,
- 7 Operation Inherent Resolve, the Global War on Terrorism,
- 8 Homeland Defense, and Operation Noble Eagle and who have
- 9 protected our borders by land, sea, and air.
- 10 Recognizing the need for such a memorial, the legislature
- 11 passed Senate Bill No. 551, S.D. 2, H.D. 1, C.D. 1, enacted as
- 12 Act 139, Session Laws of Hawaii 2013, which required the office
- 13 of veterans' services, with the assistance of the department of
- 14 accounting and general services, the department of defense, and
- 15 the state historic preservation division, to develop a plan to
- 16 establish a memorial honoring the veterans of the Persian Gulf
- 17 War, Operation Desert Storm, Operation Iraqi Freedom, Operation
- 18 Enduring Freedom, Operation New Dawn, the Global War on
- 19 Terrorism, Homeland Defense, and Operation Noble Eagle and those
- 20 who have protected our borders by land, sea, and air.

1 In response to Act 139, the office of veterans' services created the Hawaii gulf war memorial task force to develop a 2 3 plan to establish a Hawaii Gulf War Memorial. The task force held multiple monthly meetings, conducted surveys, and held a 4 public hearing on the matter. In its report to the legislature, 5 the task force stated that, based upon its findings and 6 research, the ideal spot for the memorial would be on the 7 grounds of the Hawaii State Veterans Cemetery in Kaneohe on the 8 island of Oahu. The task force also recommended that replicas 9 of the memorial be located at state veterans cemeteries 10 statewide. Finally, the task force recognized that the name 11 "Gulf War Memorial" may be too restrictive, as the intent of 12 this project is to honor not only those who have served in the 13 Persian Gulf conflicts but also those who have served in the 14 various theaters of the Global War on Terrorism. 15 16 Accordingly, the purpose of this Act is to appropriate 17 funds for the planning and design of a memorial honoring the veterans of the recent conflicts in the Persian Gulf, Iraq, 18 Afghanistan, and the various theaters of the Global War on 19 Terrorism to be situated at the Hawaii State Veterans Cemetery 20

- 1 in Kaneohe, with replicas to be located in each of the state
- 2 veterans cemeteries on the neighbor islands.
- 3 SECTION 2. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$125,000 or so much
- 5 thereof as may be necessary for fiscal year 2017-2018 for the
- 6 planning and design of a memorial honoring the sacrifices of the
- 7 service members of the recent conflicts in the Persian Gulf,
- 8 Iraq, Afghanistan, and the various theaters of the Global War on
- 9 Terrorism to be located on the grounds of the Hawaii State
- 10 Veterans Cemetery in Kaneohe on the island of Oahu, with
- 11 replicas of the memorial to be located at state veterans
- 12 cemeteries statewide.
- 13 The sum appropriated shall be expended by the office of
- 14 veterans' services, in consultation with the department of
- 15 accounting and general services, for the purposes of this Act.

16 SECTION 3. This Act shall take effect on July 1, 2017.
