### A BILL FOR AN ACT

RELATING TO APPROPRIATIONS TO ADDRESS HOMELESSNESS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the continued SECTION 1. 2 issuance of supplementary proclamations to the October 16, 2015, 3 Emergency Proclamation Addressing Homelessness by the governor 4 shows that the statewide homelessness emergency persists. The 5 coordinated statewide homeless initiative has provided 6 important, cost-effective homelessness diversion services and 7 has increased coordination within the homeless service network 8 through the statewide information and referral system on behalf 9 of homeless individuals and those at risk of homelessness.

10 In eighteen months, the initiative provided financial 11 assistance to 1,610 households, assisting 4,944 adults and 12 children who were homeless or at risk of becoming homeless by 13 providing short term assistance to prevent eviction and 14 decreasing the eviction rate in family court by twenty-five per 15 The legislature further finds that the landlord cent. 16 coordination program, established as a part of the initiative, 17 reached over seven thousand landlords and led to 1,596 rental

1 placements, which is a critical element of the effort to address 2 the homelessness issue. 3 Accordingly, the purpose of this Act is to appropriate 4 moneys to continue and improve the coordinated statewide 5 homeless initiative to prevent homelessness and rehouse homeless 6 people in the State. 7 SECTION 2. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$2,000,000 or so much 9 thereof as may be necessary for fiscal year 2018-2019 to 10 continue and improve the coordinated statewide homeless 11 initiative; provided that the following provisions shall apply: 12 (1)The department of human services shall: 13 Procure the services of a contractor in (A) 14 accordance with chapters 103D or 103F, Hawaii 15 Revised Statutes; 16 (B) Oversee the funds expended by the contractor; and 17 (C) In coordination with the selected contractor, 18 develop policies and procedures for a fair and 19 equitable procurement process for subcontracts 20 made between the contractor and subcontracted 21 provider agencies consistent with the goals of

15			use this system as the primary link between
16			landlords and the program;
17		(D)	Establish procedures to enable the landlord
18			liaison program to coordinate with the
19			coordinated entry system required by the United
20			States Department of Housing and Urban
21			Development to provide navigation services and

3	(E)	Provide oversight of provider operations and
4		budget to maximize operational efficiency;
5	(F)	Develop reporting procedures and timelines for
6		providing performance information to respective

8	(G)	Provide quarterly reports to the legislature and
9		the department of human services; and
10	(H)	Be accountable for funds expended; and
11	(3) Admi	nistrative, operating, and personnel expenses
12	shal	l not exceed fifteen per cent of the state award.
13	The sum a	ppropriated shall be expended by the department of
14	human services	for the purposes of this Act.
15	SECTION 4	. This Act shall take effect on July 1, 3000.
