# A BILL FOR AN ACT

RELATING TO NORTH ROAD.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The department of transportation shall acquire,
 by purchase or through condemnation pursuant to chapter 101,
 Hawaii Revised Statutes, the portion of North road that is
 privately owned and that traverses the Ewa Beach Golf Club, for
 the purpose of improving public safety.

6 SECTION 2. Upon acquisition of the portion of North road
7 specified in section 1 of this Act, the department of
8 transportation shall install street lighting along that portion
9 of the road.

10 SECTION 3. The director of finance is authorized to issue 11 general obligation bonds in the sum of \$ or so much 12 thereof as may be necessary and the same sum or so much thereof 13 as may be necessary is appropriated for fiscal year 2018-2019 for the purpose of acquiring the portion of North road specified 14 15 in section 1 of this Act and the installation of street lighting 16 along that portion of North road pursuant to section 2 of this 17 Act.

1 The sum appropriated shall be expended by the department of 2 transportation for the purposes of this Act. 3 SECTION 4. The appropriation made for the capital 4 improvement project authorized by section 3 of this Act shall 5 not lapse at the end of the fiscal biennium for which the 6 appropriation is made; provided that all moneys from the 7 appropriation unencumbered as of June 30, 2020, shall lapse as 8 of that date. 9 SECTION 5. There is appropriated out of the general 10 revenues of the State of Hawaii the sum of \$ or so much 11 thereof as may be necessary for fiscal year 2018-2019 for a 12 grant-in-aid to the city and county of Honolulu for the 13 installation of street lighting along the portion of North road 14 that is owned by the city and county of Honolulu. 15 The sum appropriated shall be expended by the city and 16 county of Honolulu for the purposes of this Act. 17 SECTION 6. This Act shall take effect on July 1, 2050.
