### A BILL FOR AN ACT

RELATING TO SERVICE AND EMOTIONAL SUPPORT ANIMALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Americans with
- 2 Disabilities Act, along with the Fair Housing Act, allows those
- 3 with disabilities to be accompanied by a service or emotional
- 4 support animal in places where animals are not normally allowed.
- 5 Although emotional support animals are not considered service
- 6 animals under the Americans with Disabilities Act, they are
- 7 considered as such under the Fair Housing Act.
- 8 The legislature further finds that current federal law only
- 9 allows two questions to be asked of support animal owners:
- 10 (1) Is this a service animal?
- 11 (2) What task does this service animal provide?
- 12 No request for documentation is allowed unless the owner is
- 13 asking for a housing-related accommodation.
- 14 Associations of Apartment Owners and Homeowners
- 15 Associations that have restrictions, or prohibitions, on pets
- 16 are allowed to ask for verification of a service or emotional
- 17 support animal. The verification can be a letter from a medical

- 1 provider or a form provided by the association and filled out by
- 2 the medical provider. If the pet-owner provides such
- 3 verification, no further documentation can be requested and the
- 4 pet is allowed.
- 5 The legislature further finds that many of Hawaii's
- 6 condominiums place restrictions on pets, or prohibit them
- 7 entirely. However, if a person has a service or emotional
- 8 support animal, the animal is allowed even in a no-pet building.
- 9 Consequently, there are increasing reports of fraud and abuse in
- 10 declaring pets to be service or emotional support animals in
- 11 order to circumvent pet policies, leaving associations powerless
- 12 to enforce their rules.
- Accordingly, the purpose of this Act is to establish
- 14 penalties for those who make false representations regarding
- 15 service dogs or emotional support animals to deter people from
- 16 using fraud to circumvent Associations of Apartment Owners' and
- 17 Homeowners Associations' rules.
- 18 SECTION 2. Section 347-2.5, Hawaii Revised Statutes, is
- 19 amended by amending the definition of "service dog" to read as
- 20 follows:

1 SECTION 2. Section 347-2.5, Hawaii Revised Statutes, is 2 amended to read as follows: "§347-2.5 Service dog, defined. As used in this chapter, 3 4 "service dog" means any dog that is individually trained to do 5 work or perform tasks for the benefit of an individual with a 6 disability, including a physical, sensory, intellectual, or 7 other mental disability. [A companion or comfort animal is not 8 a service dog unless it meets the requirements of this 9 definition and it accompanies a person for the purpose of 10 performing the work or tasks for which it has been trained.] " 11 SECTION 3. Chapter 347, Hawaii Revised Statutes, is 12 amended by adding a new section to be appropriately designated 13 and to read as follows: 14 Emotional support animal, defined. As used in this chapter, "emotional support animal" means any animal that a 15 16 medical professional has determined provides therapeutic benefit **17** for an individual with a disability." 18 SECTION 4. Chapter 708, Hawaii Revised Statutes, is 19 amended by adding a new section to be appropriately designated

and to read as follows:

1	"§708- Misrepresenting the use of a service dog or
2	emotional support animal. (a) A person commits the offense of
3	misrepresenting the use of a service dog or emotional support
4	animal if the person knowingly and willfully misrepresents
5	themselves, through conduct or verbal or written notice, as
6	being disabled in an attempt to receive the benefits and
7	protections afforded under federal or State law for the use of a
8	service dog or emotional support animal.
9	(b) Misrepresenting the use of a service dog or emotional
10	support animal is a misdemeanor."
11	SECTION 5. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.
13	SECTION 6. This Act shall take effect upon its approval.
