A BILL FOR AN ACT

RELATING TO NOISE CONTROL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that inadequately
 controlled noise is detrimental to the State's environment and

3 adversely affects the health, safety, and welfare of the people

4 of the State.

The legislature further finds that large commercial motorvehicles, such as refuse collection vehicles, tend to operate in

7 close proximity to residents' homes, often in the early morning

8 hours when residents are sleeping. One particularly disruptive

9 noise is that of an audible reverse warning system, or "back up

10 beeper," that is triggered when a utility vehicle reverses. The

11 loud, piercing sound of the audible warning system disrupts

12 residents' sleep, which may affect their productivity throughout

13 the day and ultimately be harmful to their health.

14 The legislature believes that prohibiting the use of

15 audible reverse warning systems during evening and early morning

16 hours, and requiring that a coworker direct the reversing of

17 large vehicles with obstructed rear views will enhance the

1 quality of residents' lives while continuing to ensure the 2 safety of surrounding persons and property. The legislature 3 also believes that restricting the use of very large motor 4 vehicles with a gross combination weight rating of 26,001 pounds 5 or more during these hours will similarly promote the health of 6 residents. 7 The purpose of this Act is to promote the health and 8 welfare of residents of the State by prohibiting the following 9 in residential zones or within one hundred feet of residential 10 zones: 11 The use of audible reverse warning systems by vehicles (1)12 after 8:00 p.m. or before 8:00 a.m. on any day; and 13 (2) The operation of motor vehicles with a gross 14 combination weight rating of 26,001 or more pounds 15 after 8:00 p.m. or before 8:00 a.m. on any day. 16 SECTION 2. Chapter 342F, Hawaii Revised Statutes, is **17** amended by adding a new section to part II to be appropriately 18 designated and to read as follows: 19 "§342F- Audible reverse warning systems; large motor

vehicles; quiet hours. (a) In any urban land use district, as

designated pursuant to section 205-2, it shall be unlawful for a

Report Title:

Audible Reverse Warning System; Large Vehicles; Residential Zones; Quiet Hours

Description:

Prohibits the use of audible reverse warning systems on vehicles operating in residential zones, except between the hours of 8:00 a.m. and 8:00 p.m. on any day. Requires operators of vehicles equipped with an audible reverse warning system to reverse the vehicle only when another person is available to direct the vehicle's reversing. Prohibits the use of motor vehicle with a gross combination weight rating of 26,001 pounds or more from operating in residential zones, except between the hours of 8:00 a.m. and 8:00 p.m. on any day. Subjects violators to a fine of up to \$1,000.
