A BILL FOR AN ACT

RELATING TO HONOKOHAU SMALL BOAT HARBOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Chapter 200, Hawaii Revised Statutes, is
3	amended by adding a new section to be appropriately designated
4	and to read as follows:
5	"§200- Honokohau small boat harbor; transfer of duties.
6	(a) The board may transfer its duties under sections 200-2 and
7	200-3 to operate, administer, manage, and maintain Honokohau
8	small boat harbor to a county in which the harbor is located.
9	(b) A county that assumes duties pursuant to this section
10	shall comply with this chapter and all other applicable laws.
11	(c) The board shall adopt rules, pursuant to chapter 91,
12	necessary for the purposes of this section."
13	PART II
14	SECTION 2. Chapter 46, Hawaii Revised Statutes, is amended
15	by adding a new section to part I to be appropriately designated
16	and to read as follows:

1	<pre>"§46- Small boat harbors; operation; administration;</pre>
2	management; maintenance. (a) In addition to other powers
3	provided under this chapter, and notwithstanding any other law
4	to the contrary, a county may operate, administer, maintain, and
5	manage a small boat harbor, as provided in subsection (b), and
6	may assume duties with respect to the small boat harbor under
7	sections 200-2 and 200-3 that are transferred to the county from
8	the board of land and natural resources as provided by statute.
9	(b) A county may operate, administer, maintain, and manage
10	a small boat harbor for the purposes of:
11	(1) Recreational boating activities;
12	(2) Landing of fish; and
13	(3) Commercial vessel activities.
14	To implement these purposes, only vessels in good material and
15	operating condition that are regularly navigated beyond the
16	confines of the small boat harbor and that are used for
17	recreational activities, the landing of fish, or commercial
18	vessel activities shall be permitted to moor, anchor, or berth
19	at a county small boat harbor or use any of its facilities.
20	(c) Nothing in this section shall be construed as
21	authorizing the board of land and natural resources to transfer



1	duties under sections 200-2 and 200-3 to a county absent
2	specific legislative authorization and county approval.
3	(d) For purposes of this section:
4	"Commercial vessel activities" means the use of vessels for
5	activities or services provided on a fee basis.
6	"Recreational boating activities" means the use of
7	watercraft for sports, hobbies, or pleasure.
8	"Regularly navigated" means the movement of a vessel under
9	its own power from its assigned mooring within a small boat
10	harbor to beyond the confines of the small boat harbor and
11	entrance channel at least once in a ninety-day period. Vessels
12	moored in an offshore mooring area shall exit the confines of
13	the designated mooring area under their own power at least once
14	in a ninety-day period."
15	PART III
16	SECTION 3. There is appropriated out of the general
17	revenues of the State of Hawaii the sum of \$ or so
18	much thereof as may be necessary for fiscal year 2017-2018 and
19	the same sum or so much thereof as may be necessary for fiscal
20	year 2018-2019 for the repair and maintenance expenses of
21	Honokohau small boat harbor.

2	of land and natural resources for the purposes of this Act.
