A BILL FOR AN ACT

RELATING TO NURSE AIDES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that an estimated twenty-2 seven thousand individuals in the State suffer from Alzheimer's 3 disease, a progressive brain disease that is the sixth leading 4 cause of death in the nation. Alzheimer's disease affects a 5 person's memory, and it eventually causes the individual to 6 experience difficulties with speech and language skills, vision, 7 decision-making, and many other daily activities such as eating 8 and grooming. The legislature further finds that the results of 9 the 2015 Hawaii Behavioral Risk Factor Surveillance Survey 10 indicate that forty-one per cent of individuals who admitted to 11 having memory problems stated that they gave up their day-to-day 12 activities due to their memory problems. Furthermore, twenty-13 eight per cent of those who indicated that they had memory 14 problems stated that they needed assistance with day-to-day activities. 15 16 The legislature further finds that, due to the nature of

- 1 for assistance with daily living activities, there is a high
- 2 demand for in-home care, adult day care, assisted living
- 3 facilities, and care homes. Assistance for the majority of the
- 4 daily life activities at these facilities is performed by nurse
- 5 aides, also known as nursing assistants.
- 6 The legislature further finds that recertification
- 7 requirements administered by the department of commerce and
- 8 consumer affairs currently include:
- 9 (1) Eight hours of employment performing nursing or
 10 nursing-related services involving direct patient care
 11 under the supervision of a licensed or registered
 12 nurse within the relevant health care setting; and
- 13 (2) Twenty-four hours of competency training, as approved
 14 by the department of human services, for nurse aides
 15 who work in a state-licensed or state-certified health
 16 care setting other than a medicare or medicaid
- The legislature finds that the complexities of the recertification process prevent a significant number of otherwise qualified nurse aides from being certified.
