A BILL FOR AN ACT

RELATING TO AQUACULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State has a

2 public interest in diversifying its economy and promoting the

3 development of innovative companies in both the blue tech

4 economy and the aquaculture industry.

5 The legislature further finds that the global aquaculture

6 industry is poised for a sustained period of growth and

7 expansion. Hawaii is home to both pioneering industry research

8 efforts and commercial activities that have made significant

9 contributions to the global aquaculture industry. To capitalize

on commercial opportunities, Hawaii must undertake a concerted

and collaborative effort to raise its visibility in the global

12 aquaculture industry.

13 The legislature recognizes that the Hawaii aquaculture 2020

14 initiative is a statewide collaborative effort to bring Hawaii's

15 diverse resources in aquaculture into a focused industry effort

16 to grow Hawaii's aquaculture industry. The legislature also

17 finds that public and private stakeholders in Hawaii's

- 1 aquaculture industry support this strategic initiative in order
- 2 to build scale in important industry inputs like feed sources
- 3 and processing capacity and to clarify permitting issues. This
- 4 strategic initiative should also support the attraction and
- 5 growth of innovative companies that will create the biological,
- 6 engineering, and operational solutions that will be demanded by
- 7 a commercial scale global industry. Beginning these efforts now
- 8 will allow Hawaii to prepare to showcase its aquaculture assets
- 9 and successes when Hawaii hosts the Aquaculture America
- 10 conference in February 2020, at the Hawaii convention center.
- 11 The legislature further recognizes that Aquaculture America
- 12 is the largest aquaculture trade show in the western hemisphere,
- 13 with nearly two hundred booths and over two thousand attendees
- 14 in recent years. The United States Aquaculture Society joins
- 15 with the National Aquaculture Association and the Aquaculture
- 16 Suppliers Association to produce the annual Aquaculture America
- 17 meetings.
- 18 The purpose of this Act is to provide the funding necessary
- 19 to support the planning and participation of the Hawaii
- 20 aquaculture industry in the Aquaculture America 2020 conference
- 21 to be held in Honolulu.

- 1 SECTION 2. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$ or so much
- 3 thereof as may be necessary for fiscal year 2018-2019 to be
- 4 expended for the planning and participation of the Hawaii
- 5 aquaculture industry in the World Aquaculture Society's
- 6 Aquaculture America 2020 conference to be held in Honolulu in
- 7 February 2020.
- 8 The sum appropriated shall be deposited into the Hawaii
- 9 strategic development corporation revolving fund, established by
- 10 section 211F-5, Hawaii Revised Statutes, and expended by the
- 11 Hawaii strategic development corporation for the purposes of
- 12 this Act.
- 13 SECTION 3. This Act shall take effect on July 1, 2112.
