BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) Pursuant to section 226-55, Hawaii Revised
- 2 Statutes, the department of land and natural resources, in

- 4 agriculture, shall prepare and periodically update a seafood

- 9 (c) The department of land and natural resources shall
 10 submit the seafood management study, including any proposed
 11 legislation, to the legislature no later than twenty days prior
 12 to the convening of the regular session of 2019.
- (d) For the purposes of this section, "wild seafood" means naturally-born or hatchery-raised fish and shellfish harvested in the wild through commercial, recreational, or subsistence fishing, but excluding net-pen aquacultural or other farm-raised fish.
- SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2018-2019 for the department of land and natural resources, in coordination
