

A BILL FOR AN ACT

RELATING TO THE ENVIRONMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

The legislature finds that the State's natural 1 environment and ecosystems are in a fragile state, due to the 2 amount of greenhouse gases released through human activities and 3 the resulting impact on global climate change. The legislature 4 5 also finds that the State should support programs that 6 incentivize state agencies, private entities, and individuals to adopt practices that are more environmentally friendly and that 7 result in reduced carbon emissions into the environment. 8 9 legislature notes that one mechanism that has gained success in 10 Europe after adoption of the Kyoto Protocol is the transferring and selling of carbon offset credits. California and numerous 11 12 other states and private industries have established these types 13 of credits for purchase by polluters to offset their carbon 14 emissions. Billions of dollars have been raised by California alone, and many industries are seeking new places to invest 15 16 these dollars to offset their carbon emissions.

1	The legislature further finds that it is necessary to
2	invest state funds to improve the State's water infrastructure
3	and ensure future water sustainability in the face of ongoing
4	climate change. More specifically, the State must be prepared
5	to provide more resources and support for those affected by
6	disaster-scale flooding, coastal seawater inundation, and
7	shortages of potable water and agricultural water. The
8	legislature anticipates that the revenues raised by a state
9	carbon offsets program will greatly enhance current water
10	sustainability efforts.
11	Accordingly, the legislature finds that it is in the public
12	interest to create a carbon offsets program in the State that
13	would incentivize and reward the adoption, practice, and
14	adherence to carbon emission reduction activities, consistent
15	with the Hawaii 2050 sustainability plan.
16	The purpose of this Act is to establish a program under the
17	department of business, economic development, and tourism that
18	allows state agencies and other interested parties to acquire
19	carbon offset credits to offset their respective carbon
20	emissions, and uses the resulting proceeds to fund projects that

- 1 improve the State's water infrastructure or mitigate threats to
- 2 water sustainability efforts due to climate change.
- 3 SECTION 2. Chapter 201, Hawaii Revised Statutes, is
- 4 amended by adding two new sections to part I to be appropriately
- 5 designated and to read as follows:
- 6 "§201- Definitions. As used in this section:
- 7 "Carbon offset" means a compensatory measure made by an
- 8 agency or individual to reduce carbon emissions, which may
- 9 include the adoption of practices that increase the absorption
- 10 of carbon dioxide.
- "Carbon offset credit" means a tradable credit issued by
- 12 the department under the program that represents a greenhouse
- 13 gas reduction or greenhouse gas removal enhancement that is
- 14 equivalent to one metric ton of carbon dioxide equivalent and
- 15 meets the requirements of the program.
- 16 "Emissions" means the release of greenhouse gases into the
- 17 atmosphere from sources and processes found in a specified
- 18 industry, including from the combustion of transportation fuels
- 19 such as natural gas, petroleum products, and natural gas
- 20 liquids.

1	"Prog	gram" means the carbon offset program administered by
2	the depart	ment.
3	<u>"Stat</u>	te agency" means a unit of state government, such as a
4	department	, division, branch, agency, program, or office, and
5	includes t	the legislature, judiciary, and office of Hawaiian
6	affairs.	
7	<u>§201</u> -	- Carbon offset program. (a) The department shall
8	establish	a carbon offset program that:
9	(1)	Establishes a process for use by state agencies and
10		other interested parties to identify management
11		actions that contribute to a reduction in carbon
12		<pre>emissions;</pre>
13	(2)	Establishes carbon offset credits that may be
14		transferred or sold among public and private entities
15		in the State; provided that carbon offset credits
16		shall be applied within the State; provided further
17		that a substantial portion of the proceeds generated
18		from sales of carbon offset credits shall be invested
19		in projects that improve the State's water
20		infrastructure or mitigate threats to water

1		sustainability due to climate change, including but
2		not limited to:
3		(A) Flood prevention and preparedness;
4		(B) Mitigation of sea level rise;
5		(C) Increasing potable water supplies; and
6		(D) Increasing agricultural water supplies;
7	(3)	Guarantees sustainable management of the State's
8		natural resources by reducing carbon emissions, based
9		on accepted principles, standards, and best management
10		practices; and
11	(4)	Is consistent with the Hawaii 2050 sustainability
12		plan.
13	(b)	The department shall adopt rules, pursuant to chapter
14	91, neces	sary to carry out the purposes of this section. At a
15	minimum,	rules adopted under this section shall address:
16	(1)	Standards to assure program participants that carbon
17		offsets to be transferred or sold under the program
18		shall:
19		(A) Not result in harm to or deterioration of natural
20	•	rogourgog in the State, and

1		(B) Provide environmental, social, cultural, or
2		economic benefits, including but not limited to
3		the improvement of the State's water
4		infrastructure or mitigation of threats to water
5		sustainability due to climate change;
6	(2)	Provisions for establishing the appropriate baseline
7		for projects or practices undertaken to reduce carbon
8		emissions;
9	(3)	Ownership of any carbon emission debits and credits
10		for carbon storage or sequestration that are made
11		through a third party or accredited program;
12	(4)	The manner in which specific industry practices shall
13		monitor and verify carbon dioxide emission for carbon
14		storage or sequestration;
15	(5)	The use of reputable third-party verification of
16		carbon offsets; and
17	(6)	The manner in which the valuation of carbon offset
18		credits shall be determined."
19	SECT	ION 3. New statutory material is underscored.

1 SECTION 4. This Act shall take effect up its approval.
