9	(1) Information related to inmates held in-state and out-
10	of-state, including but not limited to, statistics on:
11	(A) Inmate deaths; and
12	(B) Serious or violent incidents involving inmates;
13	and
14	(2) A review of the department of public safety's
15	procedures to prevent inmate deaths and serious or
16	violent incidents involving inmates."

1	SECTION 2. Section 353-16.2, Hawaii Revised Statutes, is

Inmates; Out-of-State Correctional Institutions; Public Safety; Annual Report

Description:

Requires the Director of Public Safety to submit an annual public report of information, statistics, and Department procedures on inmate deaths and serious or violent incidents involving inmates. Specifies that any inmate transferred to any out-of-state correctional institution shall remain subject to continuing Hawaii jurisdiction and may be removed from the institution pursuant to Hawaii law.
