A BILL FOR AN ACT

RELATING TO OCCUPATIONAL SAFETY AND HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 91-12, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§91-12 Decisions and orders. [Every] Except as provided
- 4 under section 396-11.5(b), every decision and order adverse to a
- 5 party to the proceeding, rendered by an agency in a contested
- 6 case, shall be in writing or stated in the record and shall be
- 7 accompanied by separate findings of fact and conclusions of law.
- 8 If any party to the proceeding has filed proposed findings of
- 9 fact, the agency shall incorporate in its decision a ruling upon
- 10 each proposed finding so presented. The agency shall notify the
- 11 parties to the proceeding by delivering or mailing a certified
- 12 copy of the decision and order and accompanying findings and
- 13 conclusions within a reasonable time to each party or to the
- 14 party's attorney of record."
- 15 SECTION 2. Section 396-11.5, Hawaii Revised Statutes, is
- 16 amended by amending subsection (b) to read as follows:

1 In all hearings before the appeals board, each board member shall have the same powers as possessed by the circuit 2 3 courts respecting the administering of oaths; issuing subpoenas; compelling the attendance of witnesses, the production of 4 documentary evidence, and the taking of depositions; and 5 6 examining or causing to be examined witnesses. The circuit court of any circuit, upon application by the appeals board or a 7 party, shall have power to enforce, by proper proceedings, the 8 9 attendance and testimony of any witness subpoenaed. Subpoena 10 and witness fees and mileage in these cases shall be the same as 11 in criminal cases in the circuit courts and paid by the party 12 calling the witness. No person shall be excused from attending, testifying, or 13 **14**. producing material, books, paper, correspondence, memoranda, and 15 other records before the appeals board or in compliance with a 16 subpoena on the grounds that the testimony or evidence, **17** documentary or otherwise, required of the person may tend to 18 incriminate the person or subject the person to a penalty or 19 forfeiture; provided that no person shall be prosecuted or 20 subjected to any penalty or forfeiture for or on account of any 21 transaction, matter, or thing concerning which the person is

- 1 compelled, after having claimed the privilege against self-
- 2 incrimination, to testify or produce evidence, documentary, or
- 3 otherwise, except that such persons testifying shall not be
- 4 exempt from prosecution and punishment for perjury committed in
- 5 testifying.
- 6 Notwithstanding section 91-12, within a reasonable time
- 7 after the appeals board issues each written order or decision,
- 8 the appeals board shall provide to each party or the attorney
- 9 for each party a copy of the written order or decision. The
- 10 written order or decision shall be hand delivered, provided by
- 11 the United States Postal Service with delivery confirmation, or
- 12 transmitted via electronic service through a company designated
- 13 by the appeals board.
- 14 Pursuant to chapter 91, the appeals board may adopt rules
- 15 of the Hawaii rules of civil procedure and other rules in
- 16 conducting any hearing."
- 17 SECTION 3. Statutory material to be repealed is bracketed
- 18 and stricken. New statutory material is underscored.
- 19 SECTION 4. This Act shall take effect on January 1, 2050.
