### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

10		appointment to the board.

12	(1)	$[\overline{\text{Ten}}]$ Five shall be contractors who have been actively
13		engaged in the contracting business for a period of
14		not less than five years preceding the date of their
15		appointment[+] and who hold a valid license to operate

2		two shall be general building contractors, [five] and

7		(A) One shall be a representative of the Hawaii

2	be eligible for appointment who does not at the time of the

5	(d) The board shall prioritize the protection of the			
6	public in the exercise of its licensing, regulatory, and			
7	disciplinary functions. When the protection of the public is			
8	inconsistent with other considerations, the protection of the			
9	public shall take precedence over all other considerations.			
10	(e) For the purpose of this section:			
11	"General building contractor" shall have the same meaning			
12	as in section 444-7(c).			
13	"General engineering contractor" shall have the same			
14	meaning as in section 444-7(b).			
15	"Specialty contractor" shall have the same meaning as in

Contractors License Board

Amends the membership of the Contractors Licensing Board by increasing the total membership to 15, reducing the number of contractors on the board to 5, and increasing the number of noncontractors to 10. Requires all members to be at least 30 years old and a resident of the State. Requires the board to hold the interests of the public as the highest priority.
