## A BILL FOR AN ACT

RELATING TO BOARDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that several boards in
- 2 Hawaii have the word "examiners" in their names even though
- 3 these boards no longer administer examinations. The purpose of
- 4 this Act is to more accurately reflect the scope and duties of
- 5 certain boards by removing the word "examiners" from the names
- 6 of the state board of chiropractic examiners, board of dental
- 7 examiners, board of examiners in optometry, and board of
- 8 veterinary examiners.
- 9 SECTION 2. Sections 26-9, 442-2, 442-3, 442-11, 442-14,
- 10 451D-2, and 663-1.8, Hawaii Revised Statutes, are amended by
- 11 substituting the term "Hawaii board of chiropractic" wherever
- 12 the term "state board of chiropractic examiners", or a similar
- 13 term, appears, as the context requires.
- 14 SECTION 3. Sections 26-9, 423-1, 447-1, 447-1.5, 447-2,
- **15** 447-3, 447-3.5, 447-4, 447-6, 447-7, 448-1.5, 448-2, 448-3,
- **16** 448-5, 448-7, 448-9.6, 448-11, 448-12, 448-13, 448-16, 448-16.5,
- 17 448-22, 448-23, and 451D-2, Hawaii Revised Statutes, are amended

- 7 the term "board of examiners in optometry" appears, as the
- 8 context requires.
- 9 SECTION 5. Sections 26-9, 451D-2, 471-1, 471-2, 471-3,
- 10 471-7, 471-8, 471-9, 471-11, and 471-14, Hawaii Revised
- 11 Statutes, are amended by substituting the term "Hawaii board of
- 12 veterinary medicine" wherever the term "board of veterinary
- 13 examiners" appears, as the context requires.
- 14 SECTION 6. This Act shall take effect on July 1, 3000;
- 15 provided that the amendments made to section 26-9, Hawaii
- 16 Revised Statutes, in sections 2, 3, 4, and 5 of this Act shall
- 17 not be repealed when section 26-9, Hawaii Revised Statutes, is
- 18 amended by section 5 of Act 181, Session Laws of Hawaii 2017.
