### A BILL FOR AN ACT

RELATING TO THE HAWAII TECHNOLOGY DEVELOPMENT CORPORATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The mission of the Hawaii technology 2 development corporation is to develop and support an innovation 3 industry in the State. In 2015, the development corporation started the neighbor island innovation initiative (NI3) program 4 5 as part of the 80 80 initiative to create 80,000 new technology 6 and innovation jobs that pay a salary of \$80,000 or more per year statewide by 2030. The program was modeled after the 7 Maryland rural business innovation initiative program, which 8 9 provides free, on-site mentorship specific to technology and

The program facilitates better access to state resources, including experienced staff, training, federal and state grant programs, and programs of partner agencies. In addition to the direct mentorship provided to companies, the program has served as a key facilitator for collaborative efforts, such as the Hawaii Island business plan competition and the Kauai Kilauea agriculture park. Since its inception, the program has met with
