## A BILL FOR AN ACT

RELATING TO HUMAN SERVICES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that because of Hawaii's 2 high cost of living and food prices that many low-income 3 individuals and families struggle to purchase food. 4 supplemental nutrition assistance program, formerly known as the 5 food stamp program, is a crucial means of providing necessary 6 assistance in the purchasing of food for some of Hawaii's most 7 disadvantaged citizens. In September 2016, 173,669 people in 8 Hawaii participated in the supplemental nutrition assistance 9 program, which is 5.1 per cent less participation than in 10 September 2015. While Hawaii secures over \$500,000,000 annually 11 in supplemental nutrition assistance program moneys, the United 12 States Department of Agriculture estimates of program 13 participation rates in 2014 ranked Hawaii thirty-fourth among 14 states in the percentage of eligible individuals that 15 participate in the supplemental nutrition assistance program. 16 The legislature also finds that if all individuals who are **17** eligible for the supplemental nutrition assistance program were

1 to participate in the program then Hawaii would receive hundreds of millions in federal funding. Additionally, Moody's Analytics 2 3 estimates that for every dollar given in supplemental nutrition assistance program funds, up to one dollar and seventy cents can 4 5 be generated in the local economy. 6 The legislature further finds that many individuals that 7 are eligible to participate in the supplemental nutrition 8 assistance program do not participate because they are unaware 9 of their eligibility or of the supplemental nutrition assistance 10 program's existence. Authorizing healthcare providers, non-11 profits, businesses, and faith-based organizations to assist 12 those in need to apply for the supplemental nutrition assistance 13 program may help with outreach and education about the benefits 14 available through participation in the supplemental nutrition 15 assistance program. Furthermore, authorizing these service **16** providers to report to the legislature an aggregate collection **17** of data about state supplemental nutrition assistance program 18 participation creates a mechanism by which policy makers can 19 better establish plans to maximize federal funding and increase 20 food security. Each of these outcomes will result in the State 21 having more supplemental nutrition assistance program

- 1 participants, which in turn will result in heightened food
- 2 security for low-income individuals and families, and more money
- 3 flowing into the State's economy.
- 4 The purpose of this Act is to authorize healthcare
- 5 providers, non-profits, businesses, and faith based
- 6 organizations to ask clients about participation in the

- 8 aggregate responses to the department of human services.
- 9 SECTION 2. Chapter 346, Hawaii Revised Statutes, is
- 10 amended by adding a new section to part II to be appropriately
- 11 designated and to read as follows:
- 12 "§346- Supplemental nutrition assistance program
- 13 participation. (a) Healthcare providers, non-profits,
- 14 businesses, and faith based organizations may provide
- 15 supplemental nutrition assistance program applications to
- 16 prospective applicants.

- 18 faith-based organizations that provide supplemental nutrition
- 19 assistance program applications to prospective applicants may
- 20 maintain a record of the distribution of the applications and,

- 1 upon request, may make the record available to the department of
- 2 human services."
- 3 SECTION 3. New statutory material is underscored.
- 4 SECTION 4. This Act shall take effect on July 1, 3000.
