# A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$520,000 or so much
- 3 thereof as may be necessary for fiscal year 2018-2019 to
- 4 maintain existing alternative learning centers or alternative
- 5 learning schools within the department of education.
- 6 The sum appropriated shall be expended by the department of
- 7 education for the purposes of this Act.
- 8 SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$260,000 or so much
- 10 thereof as may be necessary for fiscal year 2018-2019 to
- 11 establish an alternative learning center for the Nanakuli-
- 12 Waianae school complex area.
- 13 The sum appropriated shall be expended by the department of
- 14 education for the purposes of this Act.
- 15 SECTION 3. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$200,000 or so much
- 17 thereof as may be necessary for fiscal year 2018-2019 for the

- 1 planning and designing of alternative learning schools in each
- 2 of the remaining school complex areas in the State that
- 3 currently do not have an alternative learning school.
- 4 The sum appropriated shall be expended by the department of
- 5 education for the purposes of this Act.
- 6 SECTION 4. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$150,000 or so much
- 8 thereof as may be necessary for fiscal year 2018-2019 for one
- 9 full-time equivalent (1.0 FTE) position to be the director of
- 10 alternative learning schools within the department of education.
- 11 The sum appropriated shall be expended by the department of
- 12 education for the purposes of this Act.
- SECTION 5. For the purposes of this Act, "alternative
- 14 learning center" means a school that provides ongoing education
- 15 to juveniles involved in the justice system or at high-risk of
- 16 involvement in the justice system.
- 17 SECTION 6. This Act shall take effect on July 1, 2050.

### Description:

Appropriates funds to fund existing alternative learning centers or alternative learning schools, a new alternative learning school within the Nanakuli-Waianae school complex area, the planning and designing of alternative learning schools in each of the remaining school complex areas across the State, and one full-time equivalent (1.0 FTE) position to be the director of alternative schools. Takes effect on 7/1/2050. (SD1)
