### A BILL FOR AN ACT

RELATING TO LIQUOR.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 281-101, Hawaii Revised Statutes, is 2 amended to read as follows:
- 3 "§281-101 [Manufacture or sale without license;]
- 4 Unlicensed manufacture or sale of liquor; penalty. (a) If any
- 5 person, acting in person or by or through any agent, servant, or
- 6 employee, manufactures or sells any liquor, either directly or
- 7 indirectly, or upon any pretense or by any subterfuge, except as
- 8 authorized pursuant to this chapter, the person [shall be fined
- 9 not more than \$2,000 or imprisoned not more than one year, or
- 10 both.] shall be guilty of a class C felony.
- 11 (b) It is an affirmative defense to prosecution under this
- 12 section that the defendant acted under a good faith and
- 13 reasonable belief that the manufacture or sale of liquor was
- 14 authorized pursuant to this chapter."
- 15 SECTION 2. Section 712A-4, Hawaii Revised Statutes, is

2 subject to forfeiture under this chapter are:

- (a) All offenses that specifically authorize forfeiture;

4	(d) The attempt, conspiracy, solicitation, coercion, or

7	SECTION 3. Section 842-1, Hawaii Revised Statutes, is
8	amended by amending the definitions of "organized crime" and
9	"racketeering activity" to read as follows:
10	""Organized crime" means any combination or conspiracy to
11	engage in criminal activity as a significant source of income or
12	livelihood, or to violate, aid, or abet the violation of
13	criminal laws relating to prostitution, gambling, loan sharking
14	drug abuse, illegal drug distribution, counterfeiting,
15	extortion, labor trafficking, unlicensed manufacture or sale of
16	liquor, or corruption of law enforcement officers or other
17	public officers or employers.
18	"Racketeering activity" means any act or threat involving
19	but not limited to murder, kidnapping, gambling, criminal
20	property damage, robbery, bribery, extortion, labor trafficking
21	unlicensed manufacture or sale of liquor, theft, or

- 1 prostitution, or any dealing in narcotic or other dangerous
- 2 drugs that is chargeable as a crime under state law and
- 3 punishable by imprisonment for more than one year."

- 5 and stricken. New statutory material is underscored.
- 6 SECTION 5. This Act shall take effect upon its approval.

#### Report Title:

Unlicensed Manufacture or Sale of Liquor; Penalty; Organized Crime; Racketeering Activity

Adds unlicensed manufacture or sale of liquor as an offense for which property is subject to forfeiture and increases the penalty to a class C felony. Provides an affirmative defense. Amends definitions of "organized crime" and "racketeering activity" to include the unlicensed manufacture or sale of liquor.
