### A BILL FOR AN ACT

RELATING TO CHILD WELFARE SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the east Hawaii
- 2 child welfare services section on Hawaii island faces unique
- 3 challenges as the office responsible for the safety and well-
- 4 being of vulnerable children who have been abused or neglected
- 5 or who are at high risk for abuse and neglect.
- 6 The east Hawaii child welfare services section is
- 7 responsible for the safety of endangered children in a vast
- 8 geographic area that extends from Honokaa to Ocean View,
- 9 including the districts of north Hilo, south Hilo, Puna, and
- 10 much of Hamakua and Kau. This is an area approximately the size
- 11 of all of the other Hawaiian islands combined.
- 12 In 2015, the rate of confirmed cases for abuse or neglect
- 13 in the area serviced by the east Hawaii child welfare services
- 14 section was two hundred thirteen children per one hundred
- 15 thousand residents, which is nearly triple the rate of confirmed
- 16 cases per one hundred thousand residents on the island of Oahu.

1 The legislature further finds that the great recession 2 triggered deep cuts in Hawaii's already overburdened child 3 welfare system and caused a long-term impact on the safety and 4 well-being of the most vulnerable children. Layoffs and hiring 5 restrictions caused the east Hawaii child welfare services 6 section to lose nineteen of the fifty-six positions it had in 7 2009. That reduction in staffing has caused a dramatic increase 8 in average caseloads. The Child Welfare League of America 9 recommends caseloads for social workers of no more than fifteen 10 children. In the east Hawaii child welfare services section, 11 social workers regularly have caseloads of forty to fifty 12 children. These higher caseloads increase the potential for harm to children who are already experiencing or are at risk for 13 14 neglect or abuse and contribute to a crisis situation in east 15 Hawaii. 16 The east Hawaii child welfare services section workloads 17 have become so unmanageable that the department of human 18 services, child welfare services branch, has been sanctioned by 19 the family court because of late filings of reports and failure 20 to meet court deadlines.

1	Apart from the moral obligation to protect the most	
2	vulnerable children, the legislature is frustrated with the ve	ry
3	large sums of money paid each year for legal claims and	
4	settlements, including some caused by tragedies in the State's	
5	child welfare system.	
6	Child and family services reviews conducted by the United	
7	States Department of Health and Human Services have found that	
8	the more time a social worker spends with a child and a family	,
9	the better the outcomes for those children and families.	
10	The purpose of this Act is to establish a five-year pilot	
11	project within the department of human services to ensure the	
12	safety and well-being of at-risk children and families in east	
13	Hawaii on Hawaii island by:	
14	(1) Limiting the number of children supervised by each	
15	east Hawaii child welfare services section social	
16	worker to twenty or fewer; and	
17	(2) Appropriating funds for eight full-time equivalent	
18	(8.0 FTE) case managers and fifteen full-time	
19	equivalent (15.0 FTE) support staff positions in the	:
20	east Hawaii child welfare services section on Hawaii

- (3) A comparison of the number and type of sanctions imposed by the family court on the east Hawaii child welfare services section on Hawaii island because of late filings of reports and failure to meet court deadlines during the five years preceding the pilot project versus those that are imposed during the pendency of the pilot project and twelve months after it ends;
- (4) A comparison of the number of legal claims and settlements relating to the child welfare system and the east Hawaii child welfare services section on Hawaii island brought and their disposition during the five years preceding the pilot project versus those that are imposed during the pendency of the pilot project and twelve months after it ends; and
- (5) Any other data and analysis the department of human services deems necessary.

- 1 (d) Data on the conduct and efficacy of the pilot project
- 2 shall be collected by service providers that work directly with
- 3 children who are assigned to social workers in the east Hawaii
- 4 child welfare services section and shall be submitted to the
- 5 department of human services every six months for evaluation
- 6 purposes for the duration of the pilot project and twelve months
- 7 after it ends.
- 8 (e) The department of human services shall submit an
- 9 annual report of its findings and recommendations, including any
- 10 proposed legislation, to the legislature no later than twenty
- 11 days prior to the convening of the regular sessions of 2019,
- 12 2020, 2021, 2022, and 2023.
- 13 SECTION 3. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so much
- 15 thereof as may be necessary for fiscal year 2018-2019 for the
- 16 east Hawaii child welfare services section pilot project,
- 17 including the hiring of eight full-time equivalent (8.0 FTE)
- 18 case managers and fifteen full-time equivalent (15.0 FTE)
- 19 support staff positions in the east Hawaii child welfare
- 20 services section on Hawaii island.

- 1 The sum appropriated shall be expended by the department of
- 2 human services for the purposes of this Act.
- 3 SECTION 4. This Act shall take effect on July 1, 3000.
