(a) No later than , the department of 9 health shall convene a working group to discuss and provide **10** feedback on the implementation and maintenance of a forum on its 11 website where state-licensed care facilities may post vacancy 12 information to facilitate the placement and referrals of 13 individuals within state-licensed care facilities, as specified 14 in section 321-1.8(d), Hawaii Revised Statutes. 15 The department of health shall submit a report to the legislature no later than twenty days before the convening of **16** 17 the regular session of 2019 of its findings and recommendations 18 relative to the implementation and maintenance of a forum on its 19 website, as specified in subsection (a). The report shall also 20 include feedback on the posting of vacancy information on the

(a) All adult 14 residential care homes shall be licensed to ensure the health, 15 safety, and welfare of the individuals placed therein. The 16 department of health shall conduct unannounced visits, other than the inspection for relicensing, to every [licensed adult]: **17** 18 Adult residential care home [and expanded]; (1) 19 (2) Expanded adult residential care home; 20 (3) Community-based care home; and 21 (4) Adult day care center,

Department of Health Website; Vacancies for State-Licensed Facilities; Online Forum; Compensation; Caregivers; Case Managers

Description:

Establishes a forum on the Department of Health website where state-licensed care facilities may post vacancy information to facilitate the placement of individuals. Requires community-based foster family homes, adult foster homes, and adult day care centers to be licensed and to face penalties for intentionally operating without a license. (HB2279 HD1)
