A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. (a) The legislature finds that the Hawaii
 state hospital has faced a number of recurring issues over the
 past several years, including workplace safety issues,

4 employment and human resources matters, and difficulty meeting 5 the needs of patients due to the inefficient use of facilities. 6 Although the legislative and executive branches have attempted 7 to address these issues through investigative committees and 8 special action teams, concerns about the administration of the 9 hospital persist.

10 The need for the continued concern was made evident by the 11 recent high profile escape of a committed patient from the 12 hospital. The legislature finds that this escape, perhaps the 13 most visible incident at the hospital in recent history, was 14 unfortunately not an isolated incident. In fact, there have 15 been over one hundred escape incidents, also known as 16 "elopements", from the Hawaii state hospital since 2001. This

(11) Retraining staff; and

2 (12)Relocating a security post to improve visibility. In addition to these actions, the legislature notes that 3 4 the Hawaii state hospital has established a security corrective action plan. The hospital has already implemented portions of 5 6 the plan, including updating its communication plan to notify 7 the community in case of an escape and the installation of new 8 locking systems, security window screens, and fences to improve 9 security. However, the legislature finds that implementing 10 other portions of the plan will require an additional investment 11 of resources.

(b) The purpose of this Act is to appropriate funds to the
department of health to implement the outstanding
recommendations of the Hawaii state hospital security corrective
action plan.

17 (1) Appropriates funds for the purchase of electronic
