### A BILL FOR AN ACT

RELATING TO WORKERS' COMPENSATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that firefighters can be SECTION 1. 2 exposed to contaminants that are known or suspected carcinogens 3 in the course of performing their duty. Although fire 4 departments are expected to use the best equipment and 5 management practices available, firefighters are still 6 regularly exposed to multiple carcinogens, since residential and 7 vehicle fires release highly concentrated toxicants from burning 8 plastics and other synthetics. In October 2013, researchers 9 from the National Institute for Occupational Safety and Health 10 published a study that found that firefighters have a higher 11 cancer risk than the general population. The study looked at 12 cancer diagnoses and deaths among thirty thousand firefighters 13 from the Chicago, Philadelphia, and San Francisco fire 14 departments and found that oral cancer and cancers of the 15 respiratory, digestive, and urinary systems were the most 16 common types found.

1 The legislature further finds that House Concurrent 2 Resolution No. 32, H.D. 1, S.D. 1, Regular Session of 2016, 3 convened a task force to examine cancer in the firefighting 4 profession. The task force found that some states, including 5 Arizona, California, Nevada, North Dakota, and Virginia, have statutorily provided for special benefit programs for 6 7 firefighters diagnosed with cancer due to the higher 8 occupational risk they assume in the performance of their 9 essential public service. Providing sufficient worker's 10 compensation coverage for firefighters will ensure firefighters 11 receive proper medical treatment in a timely manner and also 12 lessen the emotional toil, financial burden, and the impacts of 13 a decreased quality of life on firefighters diagnosed with 14 cancer, as well as on their families.

15 The purpose of this Act is to ensure that firefighters 16 continue to receive comprehensive medical care for work-related 17 injuries, including various forms of cancer. The legislature 18 notes that this Act does not create any new benefit or enhance 19 the existing benefits available to firefighters. Rather, it 20 improves firefighters' access to comprehensive medical 21 coverage while addressing medical coverage for targeted organs

3	SECTION 2. Chapter 386, Hawaii Revised Statutes, is
4	amended by adding two new sections to part II be appropriately
5	designated and to read as follows:
6	" <u>§386-</u> Medical care, services, and supplies; controverted
7	claims. In the event of a controverted claim, the injured
8	employee's private health care plan shall pay for or provide
9	medical care, services, and supplies in accordance with the
10	private health care contract. When the claim is accepted or
11	determined to be compensable, the employer shall reimburse the
12	private health care plan and the injured employee in such amounts
13	as authorized by this chapter and rules adopted by the department.
14	§386- Medical care, services, and supplies for firefighters

19	of service as a firefighter is accepted or determined to be
20	compensable, the provisions of section 386-21 remain applicable
21	except that the employer shall be liable for medical care,

services, and supplies for a minimum of one hundred ten per cent,
and not to exceed per cent of fees prescribed in the
Medicare Resource Based Relative Value Scale applicable to
Hawaii as prepared by the United States Department of Health and
Human Services."
SECTION 3. New statutory material is underscored.
SECTION 4. This Act shall take effect upon its approval.
