A BILL FOR AN ACT

RELATING TO RECONSTRUCTED VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 286-42, Hawaii Revised Statutes, is
amended by amending subsection (a) to read as follows:

3 "(a) The county director of finance shall examine and to 4 the best of the director's ability determine the genuineness and 5 regularity of every registration and transfer of registration of 6 a vehicle pursuant to this part to ensure that every certificate 7 issued for a vehicle contains true statements of the ownership 8 of the vehicle and to prevent the registration of a vehicle by 9 any person not entitled to the vehicle. The director of finance 10 may require any applicant to furnish information, in addition to 11 that contained in the application, that is necessary to satisfy 12 the director of finance of the truth and regularity of the 13 application. The director of finance may accept any county 14 certificate of title issued for a vehicle as prima facie 15 evidence of ownership for registration and transfer of 16 registration. The director may issue vehicle identification 17 numbers for [reconstructed vehicles,] special interest 18 vehicles $[\tau]$ or motorcycles that do not have vehicle

identification numbers if the director determines that the
requirements of this section have been met.

3 The county director of finance may register a motorcycle with an aftermarket motorcycle frame, using the number of the 4 5 frame as issued by the manufacturer of the frame, the vehicle 6 identification number on the certification label, or a vehicle 7 identification number assigned by the director of finance. A 8 bill of sale and Manufacturer's Statement of Origin for the 9 frame, engine, and transmission must be presented and retained 10 as a part of the permanent county registration records. If a 11 Manufacturer's Statement of Origin is not available for the 12 engine and transmission due to the use of a used or reconstructed engine, transmission, or both, then a bill of sale 13 14 or other proof of ownership, satisfactory to the director of 15 finance must be presented. Except for motorcycles that are built on an aftermarket motorcycle frame $[\tau]$ and special interest 16 17 vehicles [, and reconstructed vehicles], any motor vehicle or 18 device that is not certified by the manufacturer to be in compliance with all applicable Federal Motor Vehicle Safety 19 20 Standards as of the date of [+] manufacture[+] shall not be 21 registered."

JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO RECONSTRUCTED VEHICLES.

PURPOSE: To amend the law relating to a County finance director's duties by removing authority to issue a vehicle identification number (VIN) to a reconstructed motor vehicle.

MEANS: Amend section 286-42(a), Hawaii Revised Statutes (HRS).

JUSTIFICATION: Some vehicle owners have been taking advantage of an apparent loop-hole in the registration law that allows a vehicle to be registered in Hawaii that is not certified by its manufacturer to comply with all applicable Federal Motor Vehicle Safety Standards (FMVSS) as of the date of manufacture.

> Section 286-42(a) requires a vehicle to have a certification label and a 17-character VIN to be registered in Hawaii. Vehicles lacking these must be brought into compliance with FMVSS by a registered importer (RI) who, after completing the required modifications, affixes a RI certification label, which allows the vehicle to be registered. This provision prevents the importation of noncompliant vehicles, which impacts motor vehicle safety.

> Recently, people have been getting uncertified vehicles registered by modifying the suspension and then getting a reconstructed vehicle inspection. The reconstructed vehicle inspector only inspects the modified portion of the vehicle for compliance with the reconstructed vehicle rules, which do not require a certification label. If the vehicle passes inspection, it receives a reconstructed vehicle permit, which is associated with the vehicle by an

assigned VIN. If the vehicle has a foreign label with something in English resembling a VIN, that number is used as a VIN. If there is no number, the police department can issue a unique VIN, provided no stolen parts are identified. Next, the vehicle is inspected by a safety inspector, who will fail it for not being registered. The failure notice and reconstructed vehicle permit are presented to the registration clerk and registration documents are made. This allows the safety inspection to be passed, and then the vehicle is ready for use on the public roads.

Removing the provision for issuing a VIN to a reconstructed vehicle will prevent these vehicles from being registered.

Impact on the public: The current situation is allowing more and more uncertified vehicles to be imported by opportunists who sell the vehicles without making any modification to them. The new owner then circumvents section 286-42(a), HRS via the above procedure. By amending section 286, HRS, such circumvention is stopped, resulting in the vehicle population having a higher percentage of safe cars, which will contribute toward improved highway safety.
