A BILL FOR AN ACT

RELATING TO THE HAWAIIAN LANGUAGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 78, Hawaii Revised Statutes, is amended
- 2 by adding a new section to be appropriately designated and to
- 3 read as follows:
- 4 "§78- Knowledge of Hawaiian language. (a)
- 5 Notwithstanding the provisions of this chapter, chapter 76, and
- 6 chapter 89, knowledge of and ability to communicate in the
- 7 Hawaiian language shall be a desirable but not mandatory
- 8 qualification in the hiring of all officers and employees.
- 9 (b) Notwithstanding subsection (a), all officers and
- 10 employees whose primary duties involve public relations or the
- 11 dissemination of information to the general public shall have
- 12 basic skills and ability to communicate in the Hawaiian
- 13 language.
- 14 (c) The director of human resources development shall
- 15 develop rules pursuant to chapter 91 to implement this section."

- 1 SECTION 2. Pursuant to article XV, section 4, of the
- 2 Hawaii State Constitution, English and Hawaiian are the official
- 3 languages of the State. The legislature finds that it is
- 4 important that public documents, including the Hawaii State
- 5 Constitution, be translated into the Hawaiian language.
- 6 SECTION 3. The University of Hawaii shall develop and
- 7 implement a program to translate public documents, including the
- 8 Hawaii State Constitution, into the Hawaiian language.
- 9 SECTION 4. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$ or so much
- 11 thereof as may be necessary for fiscal year 2018-2019 for the
- 12 University of Hawaii to develop and implement a program to
- 13 translate public documents, including the Hawaii State
- 14 Constitution, into the Hawaiian language.
- 15 The sum appropriated shall be expended by the University of
- 16 Hawaii for the purposes of this Act.
- 17 SECTION 5. This Act does not affect rights and duties that
- 18 matured, penalties that were incurred, and proceedings that were
- 19 begun before its effective date.

- 1 SECTION 6. This Act shall take effect upon its approval;
- 2 provided that section 4 of this Act shall take effect on July 1,
