A BILL FOR AN ACT

RELATING TO THE HAWAII PUBLIC HOUSING AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is a shortage 2 of affordable rental housing units to accommodate individuals 3 and families who use the section 8 housing choice voucher 4 program for housing assistance. The legislature further finds 5 that many landlords are hesitant to rent their property to 6 section 8 tenants. One of the concerns raised by landlords is 7 the inability to recover the costs of repairing damage to their 8 property when those costs exceed the amount of the security 9 deposit.

10 The purpose of this Act is to encourage landlords to rent 11 to section 8 tenants by requiring the Hawaii public housing 12 authority to establish a program that offers dwelling insurance 13 policies for landlords renting to section 8 tenants.

SECTION 2. (a) The Hawaii public housing authority shall establish a program to offer dwelling insurance policies to landlords that rent their property to section 8 tenants beginning January 1, . The Hawaii public housing

1	authority, with the cooperation of the department of commerce
2	and consumer affairs, shall establish the framework for
3	establishing the insurance program pursuant to this Act.
4	(b) The Hawaii public housing authority shall submit a
5	report of findings and recommendations, including proposed
6	legislation to establish the insurance program required under
7	subsection (a), to the legislature no later than twenty days
8	prior to the convening of the regular session of 2019.
9	SECTION 3. There is appropriated out of the general
10	revenues of the State of Hawaii the sum of \$ or so much
11	thereof as may be necessary for fiscal year 2018-2019 to
12	establish a program that offers dwelling insurance policies to
13	landlords renting their property to section 8 tenants, including
14	positions necessary to administer the program.
15	The sum appropriated shall be expended by the Hawaii public
16	housing authority for the purposes of this Act.
17	CECTION 4 This Act shall take offect on January 1 2050
