A BILL FOR AN ACT

RELATING TO REFUSE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that as the population in residential communities increases, the amount of refuse and 2 items for disposal also increases. The legislature further 3 finds that although the counties have ordinances and programs to 4 monitor the proper disposal of items, neighborhoods have seen an 5 6 increase in illegal dump sites, which creates health and safety concerns due to refuse spilling into public domains and large 7 items blocking access to sidewalks. The current procedure for 8 investigating illegal dumping violations and citing violators 9 has proven difficult because illegal dumping can be completed 10 quickly and it often occurs at night or in the early morning. 11 The purpose of this Act is to clarify that probable cause 12 for arrests by law enforcement officers of illegal dumping 13 offenders may be based upon statements from witnesses and 14 photographs, video, and other recordings that can be 15 authenticated by one or more witnesses. 16
