A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII COMMUNITY COLLEGE PROMISE PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that an educated labor
- 2 force and engaged citizenry are essential in today's global,
- 3 knowledge-based economy. Across the nation, states have set
- 4 ambitious goals to boost college completion rates. The
- 5 University of Hawaii's graduation initiative is a systemwide
- 6 strategic initiative, endorsed by the University of Hawaii board
- 7 of regents, with a goal to increase the educational capital of
- 8 the State by increasing participation in, and completion of,
- 9 college by students, particularly Native Hawaiians, low-income
- 10 students, and those from underserved regions and populations,
- 11 and preparing them for success in the workforce and their
- 12 communities.
- Moneys allocated for the University of Hawaii's community
- 14 college promise program in the 2017 state budget helped provide
- 15 scholarship opportunities to one thousand community college
- 16 students. This success demonstrates that the permanent



- 1 establishment of the program is warranted at the community
- 2 college level.
- 3 The State's 55 by '25 campaign goal focuses on increasing
- 4 the percentage of working-age adults with two- or four-year
- 5 degrees to fifty-five per cent by 2025. According to the most
- 6 recent data available, forty-four per cent of Hawaii's working
- 7 age adults have a postsecondary degree. As the State's sole
- 8 public higher education system, the University of Hawaii is
- 9 committed to doing its part to close the State's projected
- 10 educational attainment gap.
- In April 2016, the Institute for Research on Higher
- 12 Education at the University of Pennsylvania Graduate School of
- 13 Education issued a study that analyzed college costs in relation
- 14 to family income level. The study revealed how higher education
- 15 has gone from expensive to unaffordable for most low- and
- 16 middle-income families. According to the study, Hawaii ranked
- 17 third in the nation for overall college affordability. The
- 18 study also noted that the University of Hawaii community
- 19 colleges are the most affordable public two-year institutions in
- 20 the nation.

1	However, the study acknowledged that despite Hawaii's			
2	overall high affordability ranking, attending college was a			
3	large expense for families earning less than \$30,000 annually;			
4	that Hawaii's financial aid policies did little to alleviate			
5	costs for these families; and that the State provided minimal			
6	need-based aid to students attending public institutions.			
7	University of Hawaii policy requires that a minimum			
8	percentage of tuition revenue be set aside for need-based			
9	scholarships, including 8.8 per cent at the community colleges.			
10	The University of Hawaii provided \$6,300,000 in tuition-funded			
11	financial aid at the community colleges during the 2014-2015			
12	school year. Despite financial aid from sources such as Pell			
13	grants, University of Hawaii and private scholarships, the GI			
14	Bill for service members and veterans, and employers, cost still			
15	poses a barrier for certain students with financial need.			
16	The purpose of this Act is to address a statewide concern			
17	by codifying the Hawaii community college promise program to			
18	provide scholarships for the unmet direct cost needs of			
19	qualified students enrolled at any University of Hawaii			
20	community college campus and by appropriating funds to establish			
21	and implement the program.

1	SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
2	amended by adding a new section to part II, subpart B, to be
3	appropriately designated and to read as follows:
4	"§304A-A Hawaii community college promise program;
5	established. (a) Notwithstanding section 304A-501, there is
6	established the Hawaii community college promise program to be
7	administered by the board of regents. The program shall provide
8	scholarships for the unmet direct cost needs of qualified
9	students enrolled at any community college campus of the
10	University of Hawaii.
11	(b) A student enrolled at a community college campus shall
12	be eligible for scholarship consideration for a maximum of eight
13	semesters if the student:
14	(1) Qualifies for Hawaii resident tuition;
15	(2) Completes and submits the Free Application for Federal
16	Student Aid for each academic year and accepts all
17	federal and state aid, grants, scholarships, and other
18	funding sources that do not require repayment;
19	(3) Is enrolled in a classified degree or certificate
20	program with six or more credits per semester;

1	(4)	Maintains satisfactory academic progress, as defined
2		by federal requirements established pursuant to Title
3		IV of the Higher Education Act of 1965, as amended,
4		and determined by the campus where the student is
5		enrolled; and
6	(5)	Has been determined by the campus to have unmet direct
7		cost needs.
8	<u>(C)</u>	Scholarships shall be awarded to the extent possible
9	based on	available funds and on a greatest need basis. An award
10	granted t	o a student shall be equal to the student's unmet
11	direct co	st need, based on the Free Application for Federal
12	Student A	id calculation of need, less the amounts available to
13	the stude	nt from Pell grants and other scholarships.
14	<u>(d)</u>	To maintain a scholarship under this section, a
15	student s	hall meet the requirements of subsection (b)(4).
16	<u>(e)</u>	As used in this section, "direct cost" means any cost
17	directly	related to a student's education, including tuition,
18	education	al fees, and the costs of books, supplies, and
19	transport	ation between the student's dwelling and the student's
20	campus."	

- 1 SECTION 3. Chapter 304A, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part V, subpart B, to be
- 3 appropriately designated and to read as follows:
- 4 "\$304A-B Hawaii community college promise program
- 5 subaccount. (a) There is established the Hawaii community
- 6 college promise program subaccount within the University of
- 7 Hawaii general fund. Moneys in the subaccount shall be used to
- 8 provide financial assistance to qualified students through
- 9 Hawaii community college promise program scholarships under
- 10 section 304A-A.
- 11 (b) The University of Hawaii shall submit a report to the
- 12 legislature no later than twenty days prior to the convening of
- 13 each regular session with information regarding the subaccount.
- 14 The report shall include but not be limited to the number of
- 15 scholarships provided under the Hawaii community college promise
- 16 program in the preceding year.
- 17 (c) This subaccount is not intended to provide loans or
- 18 keep track of payback provisions."
- 19 SECTION 4. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$ or so
- 21 much thereof as may be necessary for fiscal year 2018-2019 to be

- 1 deposited into the Hawaii community college promise program
- 2 subaccount.
- 3 SECTION 5. There is appropriated out of the Hawaii
- 4 community college promise program subaccount the sum of
- 5 \$ or so much thereof as may be necessary for fiscal
- 6 year 2018-2019 to establish and implement the Hawaii community
- 7 college promise program, including the provision of the
- 8 program's scholarships, at the community college campuses of the
- 9 University of Hawaii.
- 10 The sum appropriated shall be expended by the University of
- 11 Hawaii for the purposes of this Act.
- 12 SECTION 6. In codifying the new sections added by sections
- 13 2 and 3 of this Act, the revisor of statutes shall substitute
- 14 appropriate section numbers for the letters used in designating
- 15 the new sections in this Act.
- 16 SECTION 7. New statutory material is underscored.
- 17 SECTION 8. This Act shall take effect on July 1, 2112.
